Marisa Olguin, President of the Vernon Chamber of Commerce

- The Vernon Chamber represents a working population of 50,000 employees of which approximately 15-20,000 working people live and vote in the City of Los Angeles
- We appreciate the concern over the City of Vernon and the Council's steps to prepare a feasibility study on the interest to annex Vernon into the City of L.A.
- We also appreciate the statement that discussion should involve the Vernon residents and business constituencies.
- To that end, there has not been sufficient time for the Vernon community comprised of its residents and business community to engage with you over the feasibility study. They are the tax paying constituencies who would be personally impacted and have everything at stake.
- The report is incomplete with certain omissions and inaccuracies that need to be addressed and we would like the opportunity to provide the facts to this Committee before it votes on this issue.
- We oppose AB 46. We are opposed to involuntary annexation from any City based on AB 46 should it pass. An annexation or a disincorporation will have devastating impact to thousands of jobs and people, most of who live within the City of L.A. boundaries.
- For this reason, we respectfully ask that the Committee would "stay" any decision and discuss with Vernon business and residents before it votes on this issue.

 My husband and I are native born Angelinos who own and operate a small business since 1973 – 26 years of which have been in the City of Vernon.

- We moved from Commerce to Vernon because Vernon is exceptionally responsive to our business operations.
- Vernon is a 100-year-old chartered municipality with City services designed to serve its community with top-ranked police and fire, environmental health, and low-cost utilities to name a few – and whose legitimacy as a municipality must be recognized.
- The City of Vernon has implemented needed reforms to better serve its community.
- The Chamber is an independent and accountable force that continues to ensure the City is making the necessary changes for a healthier form of government. The Chamber receives no funding from the City.
- An annexation or a disincorporation to the Vernon business community are equivalent
 and will have the same economic result a dramatic loss of jobs, increase in costs to
 conduct business, and a quick exodus of companies who will leave the state or country.

We ask that you postpone any vote on this proposal until we have had time to review the Feasibility Analysis report and prepare a rebuttal paper challenging some of this reports findings.
- Our country was founded on democratic principles and the people that live, work and operate businesses in the City of Vernon are asking you to respect our democratic right to keep our city independent.
