COMMUNICATION FROM CHAIR, RULES AND ELECTIONS COMMITTEE and ORDINANCE relative to the establishment of fees and bonds for recounts in connection with City elections.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

ADOPT the accompanying ORDINANCE that establishes the fees and bond requirements related to recounts of ballots cast at City elections pursuant to Subsection (d) of Section 406 of the Los Angeles City Charter and Subsection (e) of Section 1400 of the Los Angeles City Election Code.
