RE: Proposed Sewer Service Charge

To whom it may concern:

I am writing to oppose and protest the proposed sewer service charge as described in a mailing entitled "Notice of Proposed Increases in the Sewer Service Charge for the City of Los Angeles."

Your notice justified a nearly 80% increase over 10 years on the grounds that the increases will "secure the...program's standings with the credit rating agencies" which alleged will "increase[] our ability to leverage are funds more efficiently and allow[] us to reduce the overall cost of the program." In short, you attempt to justify this increase on the grounds that it will add some credibility to your already shaky reputation with the credit rating agencies and make it easier for you to borrow more and more money, whether in the credit market or through the issuance of bonds.

How stupid are you?

We are in the midst of a seemingly endless recession. Middle-class homeowners have suffered the collapse of their equity in amounts unheard since housing price records were kept. Repossessions abound and persons on fixed incomes scrimp and save to pay our County's massive property taxes.

And yet you, the City of Los Angeles Bureau of Sanitation, want more, more, and even more so you will look nice in the eyes of S&P, Fitch and Moody's.
