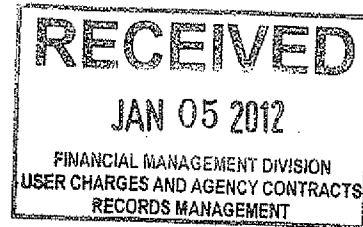


Dear Sir:

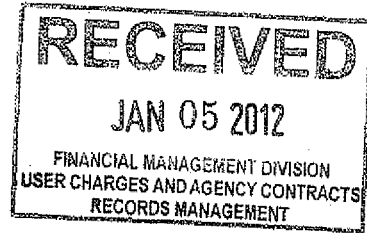

Gentlemen,

This letter is to notify you that I protest against the proposed rate increase of the Sewer Service Charge. My reasons are as follows:

1. The rate changes are excessive.
2. In the present period of high unemployment the rate changes should be deferred until the unemployment rate in Los Angeles is under 7%
3. The Sewer Service Charge should be charged equally to all single family residences and not based on water consumption
4. The Sewer Service Charge falls mainly on the house owner with landscaping
