Dear Director Zaldivar:

On behalf of the Los Angeles Area Chamber of Commerce, representing more than 1,600 businesses, which employ over 700,000 individuals throughout our region, I write to express our support for the general vision and objectives of the L.A. Wastewater Infrastructure project.

Investing in our City's infrastructure is vital to keeping Los Angeles a livable and economically competitive area. Over the last ten years sewer overflows have been reduced by 79% and through efficiency gains staff has been reduced by 28%. These gains are not only impressive, but they are proof of what a well run department can achieve. We commend the Bureau for reducing your operating costs while increasing the efficiency of the department.

In order to keep this system running smoothly the Bureau has proposed a ten year investment plan to protect and renew our aging sanitation infrastructure. While we endorse the goals of this plan, we have reservations about the immediate sharp increases. During these tough economic times businesses cannot afford to take an exorbitant increase in taxes and fees. We would like to see more modest increases to fund the highest priority actions, and revisit in another year or so after the Council, the Chamber, and the public get a better opportunity to understand the needs and prepare for the costs. It will also be easier in a recovering economy to absorb higher costs.

After two decades of minor or no rate increases, we certainly understand the need for investment. Prioritizing upgrades based on the high risk areas will allow critical upgrades to most needed neighborhoods first while calibrating the cost to business in an appropriate fashion.

We would like to reiterate our support for the vision and leadership that the Bureau of Sanitation is taking in advancing the LA Watershed Infrastructure project.
