



I am writing to voice my opposition to the increases in the SSC Rates as proposed. I find the rate increases at 4.5% to 6.5% to be excessive compared to other annual cost increases. This is especially true in light of the recent economic distress that many Los Angeles residents find themselves.

Most of us have not had cost of living increases in the last three years. In fact, many of us have had to take pay cuts just to keep the jobs we do have.

While there are signs that the economy is improving, this has yet to flow to the workers.

The 2010 consumer price index was 1.5% and the 2009 CPI was 2.7%. The consumer price index for 2011 was at 3%. Therefore, it would seem that something in the 2.7% to 3.2% would be more reasonable. I can not upderstand the need for the City to propose increases in the range of 6.5%. This is more than the consumer can absorb.
