Your PLANNING AND LAND USE MANAGEMENT Committee

reports as follows:

PLANNING AND LAND USE MANAGEMENT COMMITTEE REPORT and ORDINANCES relative to amending the Los Angeles Municipal Code (LAMC) regarding exemptions from water conservation plans and local administrative changes.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. PRESENT and ADOPT the accompanying ORDINANCE amending LAMC Section 125.06 to authorize the Department of Building and safety to approve exemptions from the requirements of water conservation plans.
- 2. PRESENT and ADOPT the accompanying ORDINANCE amending various sections of Article 3, Chapter IX of the LAMC to reflect local administrative changes and incorporate by reference portions of the 2011 Edition of the California Electrical Code.

Fiscal Impact Statement: None submitted by the City Attorney or the Department of Building and safety. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

At the public hearing held on January 25, 2011, the Planning and Land Use Management (PLUM) Committee considered Department of Building and Safety (DBS) and City Attorney reports and Ordinances relative to amending Los Angeles Municipal Code (LAMC) Section 125.06 to authorize the Department of Building and Safety to approve exemptions from the requirements of Water Conservation Plans, and amending LAMC Sections 93.0202, 93.0301, 93.0302, 93.0303, 93.0311, 93.0600, and 93.0700 to make various technical changes and incorporate portions of the 2011 California Electrical Code.

During the discussion of this matter, DBS staff gave a brief overview of the matter and addressed related questions from the Committee. After an opportunity for public comment, the Committee recommended that Council approve the Ordinances. This matter is now forwarded for Council consideration.
