SUMMARY

In the December 14, 2011, report to Council, the Planning Department provides a summary of the progress made by the Department and the Department of Transportation (DOT) relative to the implementation of the 2010 Bicycle Plan. Implementation milestones achieved during the period August through November 2011, include: receiving input from the Bicycle Plan Implementation Team, passage of a Bicycle Parking Ordinance, Think Bike LA, Spring and First Streets green lanes, and grant opportunities to support the work of the DOT Bicycle Program.

At its meeting held December 14, 2011, the Transportation Committee discussed this matter with representatives of the Planning Department and DOT. Department representatives stated that staff is conducting outreach and surveys, especially to under-served communities. Bike plan implementation is proceeding ahead of schedule. During the public comment period, support was expressed for the report and for staff performance. Encouragement was given for the construction of full bike paths. A speaker commented that new sharrows should not count toward the City's goal of 200 miles of new bikeways. The Committee recommended that Council receive and file the Planning Department report.

In the June 27, 2012, report to Council, the Planning Department provides a summary of the progress made by the Department and the Department of Transportation (DOT) relative to the implementation of the 2010 Bicycle Plan. Implementation milestones achieved during the period January through June 2012, include: receiving input from the Bicycle Plan Implementation Team, the staffing of a Bicycle Planner, the kick-off of the Environmental Impact Report for the first-year priority projects, the MyFig Project, the bike facility prioritization survey, bicycle parking programs, Bicycle Friendly Business Program, and grant opportunities to support the work of the DOT Bicycle Program.

At its meeting held June 27, 2012, the Transportation Committee discussed this matter with representatives of the Planning Department and DOT. DOT staff reported that the City is on schedule to complete 40 miles of bikeways by the end of the fiscal year. Printable maps of the new bikeways are available on-line. Department staff promotes safe cycling with education programs at area schools. Committee members suggested that staff coordinate dates of new bikeway construction and program hearings with Council offices. The Committee recommended that Council receive and file the Planning Department report.
