PERSONNEL AND ANIMAL WELFARE COMMITTEE REPORT relative to proposed Amendment No. 3 to Contract No. C-116573 with the Amanda Foundation for the provision of mobile spay/neuter services.

Recommendation for Council action:

NOTE and FILE the June 12, 2012 City Administrative Officer (CAO) report relative to Amendment No. 3 to Contract No. C-116573 with the Amanda Foundation for the provision of mobile spay/neuter services.

Community Impact Statement: None submitted.

Summary:

On January 15, 2013, you Committee considered a June 12, 2012 CAO report relative to proposed Amendment No. 3 to Contract No. C-116573 with the Amanda Foundation for the provision of mobile spay/neuter services. According to the CAO, the Department of Animal Services Department requests authority to amend the professional services agreement with the Amanda Foundation for the provision of mobile spay/neuter services. The total amount of compensation under this contract is not to exceed \$500,000 per year. This contract was awarded based on a Request for Proposals (RFP) which was issued by the Department on December 8, 2008. A Charter Section 1022 Determination was completed by the Personnel Department and found that although City employees have the expertise to perform the required work, time constraints require immediate staffing and the work assignment exceeds staffing availability. The purpose of the requested amendment is to eliminate the zip code restrictions placed on a \$50,000 donation from the Jason Debus Heigl Foundation, which was implemented on January 18, 2011 (Contract No. C-116573, Amendment No. 1. The Heigl Foundation subsequently requested to make the original donated services available to all City residents.

After consideration and having provided an opportunity for public comment, the Committee moved to note and file the CAO report. This matter is now submitted to Council for its consideration.
