WHEREAS, Christopher S. Kawai was appointed to the Los Angeles City Fire Department on February 22nd, 1977 and retired on February 17, 2012 after providing thirty-five years of honorable and faithful service to the citizens of Los Angeles in various ranks within the Los Angeles Fire Department; and

WHEREAS, Christopher S. Kawai achieved success in the most challenging of assignments and faithfully served the City of Los Angeles at Fire Stations 14, 46, 21, 22, 4, 10, 11, 1, and 26's; and

WHEREAS, Christopher S. Kawai promoted through the ranks of Engineer, Captain I and Captain II, and was promoted to Battalion Chief on February 15, 1998 and demonstrated outstanding leadership as he commanded Battalion 3, Battalion 11, the Planning Section, and Battalion 5; and

WHEREAS, during his career he fought a series of historical fires including the "Mandeville Canyon Brush Fire – 1978", "Bunker Hill Towers High Rise Fire – 1979", "Downtown Central Library Fire - 1986", "Metro Rail Tunnel Fire - 1991", "Federal Reserve Building Fire – 1998", and "Palomar Hotel Fire – 2001." In addition he responded to numerous large scale emergencies such as the "Civil Disturbance - 1992", "Echo Park Building Collapse -2000", and "Chatsworth Metro Link Train Crash – 2008"; and

WHEREAS, Christopher S. Kawai during his service to the Los Angeles Fire Department also served the Nation as a member of the Department's Federal Emergency Management Agency Urban Search and Rescue Team, California Task Force 1 (CA-TF1) and responded to some noteworthy national events including the "World Trade Center Collapse – 2001", "2002 Winter Olympics in Salt Lake City, Utah", and "Hurricane Katrina – 2005"; and

WHEREAS. Christopher S. Kawai has worked on countless special assignments and projects including Drill Tower Peer Group Instructor, Department Test Pit Engineer, Medical Dispatch Protocol Review Committee, Engineer Certification Interview Board, Tactical Alert Manual, 800-Series Rescue Ambulance Deployment Plan, Department Operational Guidelines, Engineer Practical Examination, Captain II Promotional Examination, Public Transportation Committee; and

WHEREAS, Christopher S. Kawai has served the citizens of Los Angeles in many communities including South Los Angeles, Exposition Park, Chinatown, South Park, Westlake, Contraction of the second Lincoln Heights, West Adams, Harvard Heights, University Village, Jefferson Park, Mid-

Wilshire, Pico Heights, Koreatown, Echo Park, Silverlake, Hancock Park, Wilshire Center, Hollywood, Whitley Heights, Los Feliz, Griffith Park, Hollywood Hills West, Cahuenga Pass, and Thai Town;

Melvin Stevenson Los Angeles Police Department Air Support Division Sergeant I + 3

WHEREAS, Sergeant Melvin Stevenson joined the Los Angeles Police Department on February 25, 1980, and steadily rose through the ranks working a variety of assignments during his 31½-year career; and

WHEREAS, in January 1984, then Officer Stevenson was promoted to the rank of Police Officer III and assigned and transferred to 77th Street Area. He became an excellent training officer who could instill confidence in his assigned probationers to ensure they develop a myriad of police duties with full responsibility. In November 1984, he transferred to Wilshire Area, where he continued to be an outstanding role model among probationers and peers; and

WHEREAS, in October 1988, Officer Stevenson transferred to Southeast Area and became a Vice officer. He worked a variety of duties in an undercover capacity. During his tenure as a Vice officer, he proved to be a competent investigator despite of the stressful and risky situation he handled; and

WHEREAS, in October 1988, Officer Stevenson was selected to enter the then Helicopter Observer training program at Air Support Division. Mel became known for his professionalism, and tactical expertise in an officer safety situation, projecting a cool and calming demeanor during those incidents. Thus he became known as "The MellMan," delivering that quality of service to the citizens of Los Angeles and the men and women of this Department; and

WHEREAS, in September 1993, Mel was promoted to Police Officer II+6, Command Pilot. Mel flew a variety of special assigned missions during his tenure at Air Support along with working Air Support to Regular Operations, or ASTRO, patrol missions which he performed on a daily basis, accumulating over 9, 0000 hours of flight time; and

WHEREAS, in April 2005, Mel promoted to the rank of Sergeant I and was assigned as the Assistant Watch Commander at 77th Street Area, promoting to Sergeant II in December 2006, when he transferred to Pacific/LAX Division, and later to Communications Division; and

WHEREAS, in June 2009, Mel transferred back to Air Support Division as a Sergeant I+3, Assistant Watch Commander in charge of flight operations for ASTRO patrol. He is the only assigned Department employee to have worked Air Support Division as a Helicopter

and I have

Observer, Senior Command Pilot, and Flying Sergeant Supervisor. Mel has logged over 10,000 hours of flight time during these assignments; and

WHEREAS, Sergeant Stevenson is a very special individual whose personal integrity, professionalism, and compassion has earned him the respect from people he has encouraged and motivated. He will be sorely missed by those he has impacted in a positive and personal manner; and

WHEREAS, on August 31, 2011, Sergeant I+3 Melvin Stevenson ended his long and distinguished career as a loyal City servant with the Los Angeles Police Department:

Dr. Margaret Martin Founder of the Harmony Project Recipient of the 2011 Presidential Citizens Medal

WHEREAS, Dr. Margaret Martin, founder of the Harmony Project is Los Angeles, is receiving the *Presidential Citizens Medal* from President Obama this year, one of the highest and the most prestigious honors a civilian can receive, for replacing violence in children's lives with music; and

WHEREAS, Dr. Martin and her colleagues at the Harmony Project help at-risk students stay in school and grow healthier lives and communities through music; the organization has had tremendous success with children. Harmony Project provides music instruments and music instruction from early childhood to graduation of high school, all for free, in gang-dominated Los Angeles neighborhoods; and

WHEREAS, Dr. Martin believes that the Harmony Project is not trying to develop virtuosos. Instead, the organization uses the discipline of studying and practicing music to make better students and citizens. To participate in the program, students must remain enrolled in school. So over the past four years, 100% of the high school seniors in the program have graduated on time, and gone to college; and

WHEREAS, Dr. Martin not only considers the Harmony Project a social cause, but also a public health program; its music lessons are used to fortify kids emotionally, intellectually, and physically. The program is now so popular; it has a long waiting list and is expanding to new communities.

WHEREAS, on November 4th, 2009 in a White House ceremony, Dr. Martin accepted the *Coming Up Taller* Award from First Lady Michelle Obama, on behalf of Harmony Project. Administered by the President's Committee on the Arts and the Humanities in association with the National Endowment for the Arts, *Coming Up Taller* is the nation's highest honor for an arts-based youth program. Harmony Project was the only California program to receive the award that year; and

WHEREAS, Dr. Martin founded the Harmony Project in 2001 to promote youth development after observing LA gang members stop at a Hollywood market to listen to a kid playing Brahms on a small violin. Dr. Martin realized those gang members would rather be doing what the kid was doing, but would never have the chance. She decided to dedicate her life to making quality arts education available to those in the most underserved, gang reduction zones of Los Angeles; and
