reports as follows:

RULES, ELECTIONS AND INTERGOVERNMENTAL RELATIONS COMMITTEE REPORT relative to the redistricting plans for the Los Angeles Unified School District (LAUSD); proposed modifications, adjustments and related matters.

Recommendations for Council action:

- 1. RATIFY the data fields used by the Los Angeles Unified School District Redistricting Commission (Commission) in drawing its plan (Appendix A).
- 2. NOTE and FILE the transcripts and public input provided by the Commission.
- 3. ADOPT the agreed-upon adjustment as noted in the Chief Legislative Analyst (CLA) report dated April 23, 2012, attached to the Council file, and detailed in Appendix B that would reinstate the currently existing north/south boundaries between Board Districts 3 and 4; detailed maps attached to Committee report.
- 4. ADOPT the realignment of Districts 2 and 5, including adjustments for Marshall High School and the 32nd Street and Ted Alexander Schools; detailed maps attached to Committee report (recommendation 4a of the CLA report).
- 5. NOTE and FILE the alternate LAUSD Plan (Map Av2), and instruct the CLA and the City Attorney to report back on alternatives to resolve concerns relative to the proposed District 7 boundaries (recommendation 4b of the CLA report).
- 6. INSTRUCT the Bureau of Engineering to prepare the metes and bounds for the Adjusted Map and submit them to the City Attorney to support the necessary ordinance by May 25, 2012.
- 7. REQUEST the City Attorney to prepare and transmit the necessary no later than June 8, 2012.

<u>Fiscal Impact Statement</u>: The CLA reports that no General Funds are required to implement the above actions.

Community Impact Statement: Yes.

Against Proposal: East Hollywood Neighborhood Council

Summary:

At its special meeting of April 25, 2012, the Rules, Elections and Intergovernmental Relations Committee considered reports from the LAUSD Redistricting Commission dated March 1, 2012 and the CLA dated April 23, 2012 relative to redistricting plans for the LAUSD; proposed modifications, adjustments and related matters. These reports are attached to the Council file.

During Committee discussion, the CLA and City Attorney representatives provided an overview of the recommendations and proposed modifications, and responded to related questions from Committee members. After consideration and having provided an opportunity for public comment, the Committee recommended approval of recommendation numbers 1, 2, 3, 4a, 5, and 6 in the CLA report dated April 23, 2012, and recommended to note and file CLA recommendation number 4b.

This matter is now submitted to Council for its consideration.
