

DRAFT ORDINANCE AMENDING SECTIONS 2.30, 2.31, 2.32 AND 2.33 OF THE LOS ANGELES ADMINISTRATIVE CODE TO ESTABLISH NEW BOARD OF EDUCATION DISTRICTS FOR THE LOS ANGELES UNIFIED SCHOOL DISTRICTS

Honorable Members:

As requested by your Honorable Body, this Office has prepared and now transmits for your consideration the enclosed draft ordinance amending provisions of the Los Angeles Administrative Code to establish new Board of Education Districts for the Los Angeles Unified School District (LAUSD). The ordinance has been approved as to form and legality.

On April 25, 2012, your Honorable Body voted to approve a new map for the LAUSD's seven Board of Education Districts. We have attached copies of the adopted LAUSD Board of Education District maps for ease of reference. On that same date, your Honorable Body instructed the Bureau of Engineering to prepare the metes and bounds description for the new Board of Education Districts and submit the description to the City Attorney's Office, and requested the City Attorney's Office to utilize the metes and bounds description to prepare and transmit the necessary ordinance establishing the new Board of Education Districts.

On May 22, 2012, the Bureau of Engineering provided draft metes and bounds descriptions for the new LAUSD Board of Education Districts to our Office. Pursuant to your request, we have utilized the metes and bounds description to prepare the

enclosed draft ordinance establishing new Board of Education Districts for the Los Angeles Unified School District.

Pursuant to Council Rule 38, we discussed the draft ordinance with the Bureau of Engineering, City Clerk and the Chief Legislative Analyst's Office and the enclosed draft ordinance incorporates their comments.

The provisions of this ordinance shall become effective upon publication in conformance with Los Angeles City Charter Section 252(h).




















ORDINANCE	NO.		

An ordinance amending Sections 2.30, 2.31, 2.32 and 2.33 of the Los Angeles Administrative Code to establish new Board of Education Districts for the Los Angeles Unified School District.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Section 2.30 of the Los Angeles Administrative Code is amended to read as follows:

Sec. 2.30. Board of Education Districts.

The Los Angeles Unified School District is hereby redistricted and divided into seven districts respectively numbered and constituted as follows:

Board of Education District No. 1

Sec. 2. Section 2.31 of the Los Angeles Administrative Code is amended to replace the term "July 1, 2002" with the term "June 1, 2012."

Sec. 3. Section 2.32 of the Los Angeles Administrative Code is amended to read as follows:

Sec. 2.32. Census Tracts.

The Census Tracts, as hereinbefore referred to, shall be those delineated on the United States Census Bureau's Topographically Integrated Geographic Encoding and Referencing (TIGER) files as approved by the United States Census Bureau for use in the 2010 Census.

- Sec. 4. Section 2.33 of the Los Angeles Administrative Code is amended to replace the term "2002 ordinance" with the term "2012 ordinance."
- Sec. 5. The provisions of this ordinance shall become effective upon publication in conformance with Los Angeles City Charter Section 252(h).

Sec. 6. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
