**reports as follows:**

RULES, ELECTIONS AND INTERGOVERNMENTAL RELATIONS COMMITTEE REPORT and ORDINANCE relative to amending sections of the Los Angeles Administrative Code (LAAC) to establish new Board of Education Districts for the Los Angeles Unified School District.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending sections 2.30, 2.31, 2.32 and 2.33 of the Los Angeles Administrative Code to establish new Board of Education Districts for the Los Angeles Unified School District.

Fiscal Impact Statement: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: Yes, by East Hollywood Neighborhood Council

Summary:

At its special meeting of June 13, 2012, the Rules, Elections and Intergovernmental Relations Committee considered a City Attorney report and Ordinance amending sections 2.30, 2.31, 2.32 and 2.33 of the Los Angeles Administrative Code to establish new Board of Education Districts for the Los Angeles Unified School District (LAUSD). The City Attorney reports that the City Council voted to approve a new map for the LAUSD's seven Board of Education Districts on April 25, 2012. On that same date, Council instructed the Bureau of Engineering (BOE) to prepare the metes and bounds description for the new Board of Education Districts and requested the City Attorney's Office to utilize the metes and bounds description to prepare and transmit the necessary ordinance establishing the new Board of Education Districts.

The City Attorney further reports that on May 22, 2012, the BOE provided draft metes and bounds descriptions for the new LAUSD Board of Education Districts to the City Attorney's Office. As requested, the City Attorney's Office has used this metes and bounds description to prepare the accompanying ordinance establishing the new Board of Education Districts for the LAUSD. For ease of reference, copies of the adopted LAUSD Board of Education District maps are attached to the City Attorney's report on the Council file.

During Committee discussion, representatives of the City Attorney, the Chief Legislative Analyst, and the Bureau of Engineering provided an overview of the process and Ordinance provisions, and responded to related questions from Committee members.

After further consideration and having provided an opportunity for public comment, the Rules, Elections and Intergovernmental Relations Committee recommended to adopt the accompanying Ordinance amending sections of the LAAC to establish new Board of Education Districts for the LAUSD.

This matter is now submitted to Council for its consideration.
