RE: Community Impact Statement and Resolution in Support of CF 11-0262

To the Honorable City Councilmembers:

At a publicly noticed meeting in accordance with the Brown Act the Northridge West Neighborhood Council voted to support the report sought by motion under Council File Number CF 11-0262. Specifically, that NWNC motion seeks to Reaffirm, Reiterate and Restate the NWNC's support of the Community Care Facility Ordinance (CCFO).

NWNC wishes to restate with more detail support of the Community Care Facility Ordinance to protect our neighborhoods and quality of life. (Original Motion was dated April 12, 2011 with a vote of Yea-8, No-0, and Abtain-1).

"Whereas, NWNC voted Yea-8, No-9, Abtain-1 to support CCFO in the past, it is imperative to reiterate this support and include more details now that the ordinance will soon be considered by LA City Council.

Whereas, the Community Care Facilities Ordinance is common-sense legislation that has been developed to address the proliferation of unlicensed nuisance group homes and boarding facilities that have had a huge negative impact on single family neighborhoods in Council Member Mitch Englander's District in the Northwest San Fernando Valley and in neighborhoods all across the City of Los Angeles. There are a great number of these unlicensed, unregulated facilities, most of which are for-profit businesses operating in residential areas.

geles Whereas, this ordinance is in response to families and neighborhoods in crisis who have been terrorized and unable to enjoy the peace and quiet of their own homes. Many of them will not even allow their children to play outside on their street because there are large groups of rowdy people loitering, drinking and smoking, using vulgar language, and harassing neighbors who dare to ask them to be respectful.

Whereas, these facilities generate frequent complaints, often over a period of years, of loud parties, drug and alcohol use, fights, excessive trash, public urination, heavy traffic and cars parked illegally. The illegal and unlicensed facilities often lack any kind of security, supportive services, and have unsanitary and crowded conditions, with up to 40 people in one home.

Whereas, the Ordinance is very carefully and specifically crafted so that it does not single out or discriminate against any groups, and it will not ban licensed group homes. In fact, with this new ordinance and updated definitions, people with disabilities, veterans, those living in poverty, and people afflicted by substance addiction and mental illness, will have better opportunities for housing in safe, protected and healthy living conditions. The Ordinance will help ensure that they can seek the services and support that they need without being exposed to squalid living conditions.

Whereas, the restrictions in the Ordinance are based on already existing Los Angeles zoning rules, and include requiring licensed facilities to have adequate parking, security, programs and

supervision in place and limits on numbers of residents. Legitimate, licensed, well-run facilities should be able to meet these requirements, which are meant to ensure that the neighbors' quality of life is protected.

Whereas, LAPD's crime statistics show increased crime levels near these houses.

Whereas, many other cities have this type of ordinance.

Whereas, definitions in the Ordinance will ensure that unlicensed and unregulated group homes will not be allowed in low-density, single-family home areas. See the Call to Action Letter to All Neighborhood Councils drafted by Councilman Mitch Englander on the table in this room.

Now, therefore, NWNC resolves to support the Community Care Facility Ordinance to help retain quality of life in our neighborhoods."

We encourage outreach to affected neighborhood councils to gather community input on any changes recommended by the report.

Re: SUPPORT prohibiting alcohol advertising on Los Angeles City Public Property (Council File 11-1429)

Dear Councilmember Mitchell Englander,

As concerned community members we are troubled by the advertisement of alcohol on public property. At a time when there is a lack of services to treat alcohol related harms, the City of Los Angeles should not participate as a promoter of alcohol. Councilmember Richard Alarcón agreed with us and introduced a motion (Council File 11-1429) directing the City Attorney to prepare an ordinance prohibiting alcohol advertising on city-owned and controlled property.

Families and youth utilize city owned and controlled property on a daily basis, such as school buildings, recreation centers, libraries and bus shelters. To the extent that commercial advertising is allowed in these public facilities, the City of Los Angeles can play a positive role in reducing exposure of alcohol advertising. We ask that as the Chair of the Public Safety Committee you add your vote in support of prohibiting alcohol advertising on city-owned and controlled property.

The L.A. County Department of Public Health recommends "reducing alcohol advertising in public spaces and in areas commonly seen by minors," as a way to help discourage underage drinking. Currently the Los Angeles MTA does not allow alcohol advertising on its buses, trains and other transit facilities.

We would like to clarify that local government has the legal and constitutional right to ban alcohol ads on its property. We hope that you can consider this request and look at the cost of alcohol in a way that can truly capture the economic impact it has on Los Angeles City services and the community at large.

We respectfully urge you to adopt a citywide policy prohibiting alcohol ads on public property.
