Notice is hereby given to file arguments for the following measure to be voted on at the special community facilities district election to be held in the City of Los Angeles Community Facilities District No. 9 (Downtown Streetcar) (the "Community Facilities District") on Monday, the 3rd day of December, 2012: DOWNTOWN STREETCAR COMMUNITY FACILITIES DISTRICT
Shall City of Los Angeles Community Facilities District No. 9 (Downtown Streetcar) be authorized to incur bonded indebtedness in a maximum amount of not to exceed \$85,000,000 and levy a special tax in order to finance certain downtown Los Angeles streetcar system facilities and shall the annual appropriations limit of said Community Facilities District be established in the amount of \$85,000,000, all as specified in Ordinance No. 182191 and Ordinance No. 182192?

Completed author request forms either for or against the measure should be submitted by August 31, 2012 by 5:00 p.m. to: Herb J. Wesson Jr., Council President, C/O Office of the City Clerk, Attn: Shannon Hoppes, 200 North Main Street, City Hall Room 395, Los Angeles, CA 90012.

Authors of arguments and rebuttal arguments shall be designated, with the approval of the Rules, Elections and Intergovernmental Relations Committee of the City Council, by the City Council President. Those designations will be made at a meeting tentatively set for September 4, 2012 at 8:30 a.m.

Designated authors will be provided further instructions and forms by the City Clerk. No argument shall exceed 300 words in length. Arguments must be filed with the City Clerk of the City of Los Angeles, Election Division, Piper Technical Center, 555 Ramirez Street, Space 300 Los Angeles California 90012, no later than 5:00 p.m. on September 10, 2012.

The authors of each such argument may prepare and submit a rebuttal argument, which shall not exceed 150 words in length. Such rebuttal arguments must be submitted to the City Clerk Election Division at the above Piper Technical Center address no later than 5:00 p.m. on September 19, 2012.
