July 2006 Red Car Feasibility Study

Federal Appropriation secured by Congressmember Lucille Roybal-Allard

2008 Streetcar Delegation to Portland & Seattle arranged by Councilmember

Two dozen downtown leaders and stakeholders, including the E.D.s or members of each Business Improvement District in the streetcar area.

May 2008 Los Angeles National Streetcar Conference

Several hundred people attended the conference held at the Orpheum Theatre. The conference featured speakers from across the United States and was the largest event of its kind in the United States.

Dec 2008 CRA/LA allocated \$10M to Streetcar Project

2009 Formation of Los Angeles Streetcar, Inc.

Non-profit formed with initial Board Members from downtown Business Improvement District Executive Directors, property owners, and stakeholders.

July 2009 Streetcar Open House

Los Angeles Streetcar, Inc., hosted a public open house to solicit alignment alternatives and inform the public of the project's progress.

Apr 2009 Central City Community Plan / General Plan Amendment (CF 09-0385)

The streetcar project was formally adopted into the Central City Community Plan on April 24, 2009.

Aug 2009 Streetcar Design Charrette

Mass mailing of property owners and residents in the streetcar area More than 120 people attended an all-day workshop at the Los Angeles Theatre Center to discuss 6 route options. The charrette specifically focused on how the streetcar could best integrate with streetscapes, other transit systems, and pedestrian enhancements.

CRA/LA formally awards Los Angeles Streetcar, Inc., \$400,000 to conduct a detailed analysis of potential funding sources for the streetcar project, including the formation of local assessment and special tax districts.

2010 BID Presentations

In 2010, Los Angeles Streetcar, Inc., presented the streetcar project and its benefits to all of the BIDs within the Community Facilities District benefit area. The presentations included a description of the private-sector local financing commitment that would be required to advance the project.

Feb 2010 Streetcar Awareness Campaign

Los Angeles Streetcar, Inc., launched an ad awareness campaign around downtown, including the installation of ads in bus shelters, billboards, and distribution of informational material around downtown L.A.

July 2010 CRA/LA, City of LA, and Metro MOU (CF 10-0937)

A Memorandum of Understanding is established between the CRA/LA, the City, and Metro to jointly complete the required environmental documentation needed to advance the project for federal funding.

Sept 2010 Get On Board Fundraising Event

Los Angeles Streetcar, Inc., hosted a fundraising event at the L.A. Live Target Terrace with over 310 attendees.

Oct. 2010 - Feb 2011 Individual Property Owner Meetings

Los Angeles Streetcar, Inc., met with property owners with land holdings throughout the Community Facilities District benefit area. LASI also prepared parcel lists with special tax amounts for property owners who requested additional detail.

Feb 2011 Economic Press Conference

Los Angeles Streetcar, Inc., CD-14, CD-9, and other stakeholders hosted a press conference to reveal the findings of a streetcar economic impact study. The result found that the streetcar project will directly generate over \$1 billion dollars in new development, 9,300 new jobs, \$24.5M in new annual spending within downtown L.A., and \$47M in new revenue to the City.

May 2011 DCBID Board of Directors CFD Briefing

Los Angeles Streetcar, Inc., presented the proposed CFD methodology to the DCBID Board of Directors. The methodology presented included operations and building square footage, which was roughly 40% higher than currently proposed.

May 2011 DLANC Briefing RE: Alternatives Analysis Process

On May 10, 2011, Metro staff and consultants presented to the Downtown Los Angeles Neighborhood Council the various alignments being considered, the public-private funding mechanisms, and solicited feedback/input to direct the Alternatives Analysis process.
