



COMMUNICATION FROM CHAIR, PUBLIC SAFETY COMMITTEE relative to amending the Los Angeles Interagency Metropolitan Police Apprehension Crime Task Force (L.A. IMPACT) Joint Powers Agreement (JPA).

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

APPROVE the proposed amendments of the L.A. IMPACT JPA to approve associate member indemnity and state contracting goals for disabled veterans' businesses changes.

Fiscal Impact Statement: None submitted by the Los Angeles Police Department (LAPD). Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

In a report to the Board of Police Commissioners dated February 8, 2013 (attached to the Council file), LAPD recommends approval of proposed amendments of the L.A. IMPACT JPA to approve associate member indemnity and state contracting goals for disabled veterans' businesses changes. According to LAPD, the City Attorney has approved the new JPA which is attached to the Council file. On February 12, 2013, the Board approved LAPD's recommendation.

At the special Public Safety Committee meeting held March 27, 2013, the Committee Chair recommended that Council approve the proposed amendments of the L.A. IMPACT JPA, as recommended by the Board of Police Commissioners.
