I HEREBY MOVE that Council ADOPT the following recommendations relative to the modification of the Panorama City Property and Business Improvement District's (PBID) Management District Plan, pursuant to Section 36600 et seq. of the California Streets and Highways Code (Item No. 1, Council file No. 11-0785), SUBJECT TO THE APPROVAL OF THE MAYOR:

1. HEAR PROTESTS against the proposed modification of the Panorama City PBID's Management District Plan, pursuant to Section 36600 et seq. of the California Street and Highways Code.
2. PRESENT and ADOPT the accompanying ORDINANCE modifying the Panorama City PBID Management District Plan as described in Ordinance 181791, if a majority protest, as defined by Section 53753 of the California Government is found not to exist.
3. AUTHORIZE the City Clerk, subject to the approval of the City Attorney, to amend Contract C-116426 between the City of Los Angeles and the Panorama City Business Improvement District, Inc. as needed to administer the Panorama City PBID's program upon adoption of the Ordinance modifying the Management District Plan.
