Council Action

The City Council ADOPTED the following recommendation(s), contained in a COMMUNICATION FROM THE CITY ATTORNEY which was WAIVED, pursuant to Council Rule 17, by the Chair of the Energy and Environment Committee, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. FIND that in accordance with the California Environmental Quality Act (CEQA), it has been determined that this ordinance is not subject to CEQA because it is not a project as defined by State CEQA Guidelines 15378(b)(2) and (b)(5). Exempt under common sense exemption through State CEQA Guidelines 15061(3) and City of Los Angeles CEQA Guidelines, Article II, (1), as the ordinance simply transfers authority for the implementation and enforcement of the shopping cart containment requirements between bureaus.
2. PRESENT and ADOPT the accompanying ORDINANCE amending Subsection F of Section 12.21 of the Los Angeles Municipal Code to transfer responsibility and authority for the implementation and enforcement of the on-site shopping cart requirements from the Bureau of Street Services to the Bureau of Sanitation.
