**Supporting Motion to Prepare a Ridgeline Ordinance**  
**Council File # 11-1441-S1**

We, Robin Greenberg and Nickie Miner, declare that we are the President and Vice President respectively of the Bel Air Beverly Crest Neighborhood Council (BABCNC), and that on September 28, 2016, a Brown-Act noticed public meeting was held by the BABCNC, with a quorum of 16 board members present and that by a vote of 16 yes, 0 no, and 0 abstentions, the Bel Air Beverly Crest Neighborhood Council voted unanimously to support the Ridgeline Ordinance motion of Councilmembers *Paul Koretz* and *David Ryu* (CF 11-1441-S1) asking that Planning Department prepare a report with updated cost information to prepare a Ridgeline Ordinance with development standards, inasmuch as the prior estimates were prepared in 2011 (CF#11-1441 File expired 2014), and that the Planning Department also report on the feasibility of a Ridgeline Ordinance as part of the current FY 2015-16 Planning Department work program.
