

COMMUNICATION FROM CHAIR, HOUSING, COMMUNITY AND ECONOMIC DEVELOPMENT COMMITTEE relative to authorization to reprogram \$45,000 in Community Development Block Grant (CDBG) savings from the Boyle Heights Neighborhood City Hall to the El Centro de Ayuda FamilySource Center.

Recommendations for Council action, pursuant to Motion (Huizar – Buscaino), SUBJECT TO THE APPROVAL OF THE MAYOR:

1. REPROGRAM CDBG funds in the amount of \$45,000 from the Boyle Heights Neighborhood City Hall to the El Centro de Ayuda FamilySource Center, subject to CDBG review and eligibility.
2. AUTHORIZE the Controller to:
 - a. Establish a new account, if necessary, for El Centro de Ayuda FamilySource Center, in the amount of \$45,000 within the Community Development Trust Fund No. 424.
 - b. Decrease Account 22J501 - Boyle Heights Neighborhood City Hall in the amount of \$45,000 within the Community Development Trust Fund No. 424.
3. AUTHORIZE the General Manager, Community Development Department, or designee, to prepare Controller instructions and/or make technical adjustments that may be required and are consistent with this action, subject to the approval of the City Administrative Officer (CAO), and AUTHORIZE the Controller to implement these instructions.

Fiscal Impact Statement: Neither the CAO nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At a regular meeting held on May 1, 2013, the Chair of the Housing, Community and Economic Development Committee considered Motion (Huizar – Buscaino) relative to authorization to reprogram \$45,000 in Community Development Block Grant (CDBG) savings from the Boyle Heights Neighborhood City Hall to the El Centro de Ayuda FamilySource Center, a certified Community Based Development Organization. The Motion states that the funding will be used for facility operations, including purchase of equipment and/or furniture required to operate the two computer labs and community room.

After providing an opportunity for public comment, the Committee Chair recommended approval of the recommendations in the Motion. This matter is now forwarded to Council for its consideration.
