PUBLIC SAFETY COMMITTEE REPORT and ORDINANCE FIRST CONSIDERATION relative to decreasing the noise variance application fee, revising the entire Business Permit Fee Schedule for police permits, and increasing the false alarm fee.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending Sections 41.40, 103.12, and 103.206 of the Los Angeles Municipal Code to decrease the noise variance application fee from \$253 to \$248, revise the entire Business Permit Fee Schedule for police permits, and increase the false alarm fee from \$159 to \$162.

<u>Fiscal Impact Statement</u>: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

Accompanying a report to Council dated October 25, 2013 (attached to the Council file), the City Attorney presents Ordinance decreasing the noise variance application fee, revising the entire Business Permit Fee Schedule for police permits, and increasing the false alarm fee. The City Attorney reports that the Ordinance was prepared pursuant to Council action of September 25, 2013, amending the fees for police permits, as recommended by the Los Angeles Police Department and the Board of Police Commissioners. At its meeting held December 13, 2013, the Public Safety Committee recommended that Council approve the accompanying Ordinance.
