

REVISED DRAFT ORDINANCE AMENDING SECTIONS 41.40, 52.16, 103.12 AND 103.206 OF THE LOS ANGELES MUNICIPAL CODE TO ADD: (1) AN INCREASE IN THE NOISE VARIANCE APPLICATION FEE, (2) AN INCREASE IN THE FEE FOR THE ISSUANCE OF NEWS MEDIA IDENTIFICATION CARDS, AND (3) AN INCREASE IN THE FALSE ALARM FEE; AND TO REVISE THE BUSINESS PERMIT FEE SCHEDULE

Honorable Members:

We are transmitting to you for your consideration, approved as to form and legality, a revised draft ordinance that would amend Sections 41.40, 52.16, 103.12 and 103.206 of the Los Angeles Municipal Code (LAMC). The revised draft ordinance would add provisions to: (1) increase the noise variance application fee, (2) increase the fee for the issuance of news media identification cards, and (3) increase the false alarm fee; and it would also revise the Business Permit Fee Schedule for police permits.

This Office previously transmitted a draft ordinance (City Attorney Report No. R12-0363) that would revise the Business Permit Fee schedule for police permits and increase the false alarm fee. Since that draft ordinance was transmitted, it has come to our attention that the Public Safety Committee's report relative to the Police

Department's 2013 fees for Special Services and Police Permits also included the increase of the noise variance application fee and the fee for issuance of news media identification cards. Accordingly, the revised draft ordinance includes these two additional fee increases. Additionally, two other changes required to the Business Permit Fee Schedule contained in the previously transmitted draft ordinance have been made in the enclosed revised draft ordinance. In all other respects, the revised draft ordinance is identical to the draft previously transmitted and described in the earlier report.

Fee Notice Requirement

We note that, because this ordinance would effectuate an increase in existing fees, notice of its proposed adoption should be given in accordance with the provisions of California Government Code Sections 66018 and 6062a. Those sections of State law require that prior to adoption of a new or increased fee a public hearing be held and notice of that hearing be published in a newspaper with two publications at least five days apart over a ten-day period. The notice period begins the first day of publication, and there must be at least five days intervening between the first and the second publications, not counting the dates of publication.

A copy of the draft ordinance was sent, pursuant to Council Rule 38, to the Board of Police Commissioners and the City Administrative Officer with a request that all comments, if any, be presented directly to the City Council or its Committees when this matter is considered.

An ordinance amending Sections 41.40, 52.16, 103.12 and 103.206 of the Los Angeles Municipal Code to increase the Noise Variance application fee, increase the fee for issuance of News Media Identification Cards, increase the False Alarm fee, and revise the Business Permit Fee Schedule.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

- Section. 1. Subsection (k) of Section 41.40 of Article 1 of Chapter IV of the Los Angeles Municipal Code is amended to read as follows:
- (k) **Noise Variance Application Fee.** Any application to the Board for a noise variance under Subsection (b) shall be accompanied by payment of an application fee of \$253.00.
- Sec. 2. Subsection (H) of Section 52.16 of Article 2 of Chapter V of the Los Angeles Municipal Code is amended to read as follows:
- **H.** The fee for issuance of a card shall be \$25.00, provided however that no fee shall be charged for the reissuance of such card.
- Sec. 3. The Business Permit Fee Schedule of Section 103.12, Division 4, Article 3, Chapter X of the Los Angeles Municipal Code is amended to read as follows:

Sec. 4. Paragraph (1) of Subsection (e) of Section 103.206, Division 8, Article 3, Chapter X of the Los Angeles Municipal Code is amended to read as follows:

(1) **False Alarm Fees.** Alarm System Users shall pay a False Alarm Fee of \$159.00 for each False Alarm.

Sec. 5. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
