I am writing to express my serious concern over for your motion to repeal certain provisions of the Municipal Code pending regulation, without any due process. What inconsistencies? You have created a fast-track, quietly introduced Motion that has not been noticed or vetted. It states there are "inconsistencies" but does not explain what they are.

One size does not fit all. Safety is paramount, both to the disabled, and to those who use our public highways. It is paramount to those who need the immediate attention of emergency vehicles who have nowhere to park or gain access to residents in apartments. It jeopardizes our firefighters and our police who have nowhere on busy, windy streets to stop. It is something that is being misused. It is something, where needed, should be allowed by a paid permit out of necessity, and not "by right".

The reason why the City has been sued is over the abuses by those very residents where you give them an arm, they take a leg. They have no consideration for disabled residents and this will allow them to continue to block not only the sidewalk, but the apron that is required for emergency parking by emergency vehicles. It will be misused by those who have permit parking and garages who would rather store their cars along the public parkway on their apron than use their garages for what they were intended.

This "quick fix" will promote more litigation while the City winds its slow way through the ordinance process.

There currently exists an inconsistency regarding the definition of "parkway" in the Los Angeles Municipal Code. (See Sections 42.00 and 80.00(h).) In light of this inconsistency, **enforcement of Section 80.53 of the Municipal Code should be suspended unless and until the City adopts other laws regulating apron parking.** Of course, the provisions of California Vehicle Code Section 22500 shall remain in effect. I THEREFORE MOVE that the City Attorney be requested to prepare and present an ordinance to repeal Section 80.00(h) of the Municipal Code so that the definition of "parkway" is consistent throughout the Municipal Code.

I FURTHER MOVE that the City Attorney report in closed session and in accordance with the Brown Act on the status of apron parking as related to Sections 42.00 and 80.00(h) of the Municipal Code.

On behalf of the constituents living in the Westwood South of Santa Monica Blvd. Homeowners Association community, we ask that you vote to **support Council File 11-1676** when it is heard in Council on Wednesday, October 12th. We are a residential community located 3 miles south of Westwood Village where apron parking was found to encroach upon sidewalks and were surprised to find our area and vehicles targeted in an enforcement crackdown when our residents did not block sidewalks.

Many of our residents have been ticketed for parking on the aprons adjacent to their homes and apartments since enforcement of the apron parking ban began in late June. Their vehicles did not enter the sidewalk areas or impede able-bodied or disabled pedestrians seeking to use the sidewalks. In fact, since the enforcement of the apron parking ban began, disabled residents have been unable to access their homes and vehicles since their parking was lost. Additional safety hazards have developed when residents have been forced to park at a distance from their homes thus exposing them to the dangers of crossing busy streets and having to walk long distances, often late at night.

Many of the properties where apron parking exists are older residences that provide important AFFORDABLE housing. Forcing the removal of the apron parking jeopardizes the long-term viability of this much-needed housing stock.
