For the past 5 years, our Melrose Hill Neighborhood has been blighted by vehicles pushing down newly planted City street trees and parking on our grass parkways and blocking our commercial sidewalks. For the last 5 years, your local Hollywood Parking Enforcement Officers have explained to us that they cannot cite the vehicles on either our residential grass parkways or our paved commercial pedestrian sidewalks. Yes, that includes our commercial sidewalks, which is really bizarre.

Is there any chance of effective enforcement. We are sure your intent is not to blight our neighborhood. Please note that we have no objection to parking in the driveway apron. Our concern is with your staffs INTERPRETATION that it somehow applies to blighting our parkways, destroying our street trees, and blocking our commercial pedestrian sidewalks.
