The Endangered Habitats League (EHL) urges passage of the Citywide Sign Ordinance Revisions as presented to the PLUM committee on Dec. 4, 2012. For your reference, EHL is Southern California's only regional conservation group and is dedicated to improving the quality of urban life as part of comprehensive land use planning.

This ordinance is urgently needed to protect communities from the toxic effects of sign blight on the urban fabric and from its debilitating impact on people's mental health. It is also needed to stop the blatant disregard of sign laws that blanketed the city with illegal signs in the past.

In particular, we urge you to resist *any* attempt to include provisions in this ordinance regarding the re-permitting of digital billboards ruled illegal by the court. Such action would be a travesty and demonstrate control of city government by billboard interests.
