PUBLIC SAFETY COMMITTEE REPORT relative to the status of the Illegal Dumping Reward Program Trust Fund No. 46G.

SUMMARY

In a report to the Mayor and Council dated September 20, 2012, the City Clerk states that the fund balance for the Illegal Dumping Reward Program Trust Fund No. 46G was \$0.00 as of June 30, 2011. The Fund realized revenue in the form of a transfer of \$1,000 from the Reserve Fund. An expenditure of \$1,000 was made for the payment of one reward, leaving a balance of \$0.00 as of June 30, 2012. According to the City Clerk, the Fund was established in 2002 for the deposit of money for, and payment of rewards to persons who, in response to the offer of reward, have provided information resulting in the identification, apprehension, and conviction or a final adjudication by the Juvenile Court or placement on a supervised program by the probation officer under the provisions of the Welfare and Institution Code of the State of California, of, or as to, the person or persons who have committed acts of illegal dumping. At its meeting held October 12, 2012, the Public Safety Committee recommended that Council note and file the City Clerk's report.
