In reports to the Mayor and Council dated October 13, 2011, the City Clerk presents the annual status of the Illegal Dumping Reward Program Trust Fund No. 46G for Fiscal Years 2010 and 2011. During the reporting periods, funds were transferred into the Fund for illegal dumping reward payments. According to the City Clerk, the Fund was established in 2002 for the deposit of money for the payment of rewards to persons who have provided information resulting in the apprehension and conviction of person or persons who committed acts of illegal dumping. At the Public Safety Committee meeting held November 4, 2011, the Committee Chair recommended that Council note and file the City Clerk reports.
