PUBLIC SAFETY COMMITTEE REPORT relative to the status of the Illegal Dumping Reward Program Trust Fund No. 46G for Fiscal Year (FY) 2012-13.

SUMMARY

In a report to the Mayor and Council dated October 17, 2013, the City Clerk states that the fund balance for the Illegal Dumping Reward Program Trust Fund No. 46G was \$0.00 as of June 30, 2012. The Fund realized net revenue in the amount of \$0.00, and total expenditures and encumbrances in the amount of \$0.00, leaving a balance of \$0.00 as of June 30, 2013. According to the City Clerk, the Fund was established in 2002 for the deposit of money for, and payment of rewards to persons who, in response to the offer of reward, have provided information resulting in the identification, apprehension, and conviction or a final adjudication by the Juvenile Court or placement on a supervised program by the probation officer under the provisions of the Welfare and Institution Code of the State of California, of, or as to, the person or persons who have committed acts of illegal dumping.

At its meeting held November 8, 2013, the Public Safety Committee recommended that Council note and file the City Clerk's report.
