SUMMARY

In reports to the Mayor and Council dated October 13, 2011, the City Clerk states that the fund balance for the Council District 13 Public Assistance Trust Fund No. 904 for FY 2010 was \$24,112.91, and \$4,491.36 as of June 30, 2011. Fund activities include interest earned, and an expenditure in the amount of \$20,000 with the Los Angeles Conservation Corps. According to the City Clerk, the Fund was established in 1997 for the receipt, retention, and disbursements of gifts, contributions, and bequests for the support of police and community activities within Council District 13. At the Public Safety Committee meeting held November 4, 2011, the Committee Chair recommended that Council note and file the City Clerk reports.
