SUMMARY

In reports to the Mayor and Council dated October 13, 2011, the City Clerk states that the fund balance for the Council District 15 Los Angeles Police Department Harbor Division Police Assistance Trust Fund No. 888 for FY 2010 was \$12,224.53, and \$12,456.51 as of June 30, 2011. Interest accrued during the reporting periods, but no other activity was reported. According to the City Clerk, the Fund was established in 1995 for the receipt, retention, and disbursements of gifts, contributions, and bequests for the support of the Police Department's Harbor Division. At the Public Safety Committee meeting held November 4, 2011, the Committee Chair recommended that Council note and file the City Clerk reports.
