SUMMARY

In a report to the Mayor and Council dated September 20, 2012, the City Clerk states that the fund balance for the Council District 12 Los Angeles Police Department Devonshire and Foothill Divisions Police Assistance Trust Fund No. 883 was \$132.19 as of June 30, 2011. The Fund realized interest revenue in the amount of \$3.46 leaving a balance of \$135.65 as of June 30, 2012. According to the City Clerk, the Fund was established in 1994 for the receipt, retention, and disbursement of gifts, contributions, and bequests for the operation of the Police Department's Devonshire and Foothill Divisions. At its meeting held October 12, 2012, the Public Safety Committee recommended that Council note and file the City Clerk's report.
