Interest accrued during the reporting periods, but no other activity was reported. According to the City Clerk, the Fund was established in 1994 for the receipt, retention, and disbursements of gifts, contributions, and bequests for the support of the Police Department's Devonshire and Foothill Divisions. At the Public Safety Committee meeting held November 4, 2011, the Committee Chair recommended that Council note and file the City Clerk reports.
