**RE: Community Impact Statement in Support of CF 11-1878**

To the Honorable City Councilmembers:

At a publicly noticed meeting in accordance with the Brown Act the North Hills West Neighborhood Council voted to support the report sought by motion under Council File Number 11-1878. Specifically, that motion seeks information on:

(a) The current management structure at Van Nuys Airport and options for enhancing participation of the LAWA staff and the BOAC in the San Fernando Valley;

(b) Practicability of creating a separate Airport Commission for Van Nuys Airport, including the advantages and disadvantages that would result from the creation of that Commission; and

(c) Feasibility of transferring the operation and administration of Van Nuys Airport to a private management firm with examples of privately run airports of comparable size and operations.

We encourage outreach to affected neighborhood councils to gather community input on any changes recommended by the report.
