DRAFT ORDINANCE AMENDING THE LOS ANGELES ADMINISTRATIVE CODE REGARDING THE 2014 NEIGHBORHOOD COUNCIL ELECTIONS

Honorable Members:

Pursuant to your request, this Office has prepared and now transmits for your consideration the enclosed draft ordinance, approved as to form and legality, amending the Los Angeles Administrative Code (LAAC) to allow the City Clerk and Department of Neighborhood Empowerment (Department) to jointly administer Neighborhood Council elections during the 2014 calendar year. The draft ordinance would amend LAAC Sections 20.36 and 22.816, eliminate obsolete provisions from these sections, and clarify the joint role of the City Clerk and the Department in administering the 2014 elections.

In addition, the Plan for a Citywide System of Neighborhood Councils (Plan) should be amended to correctly reflect the administration of elections by the City Clerk and the Department in 2014. Included within this report is a proposed Resolution for Council that would amend the Plan to reflect the joint administration of elections by the City Clerk and Department in 2014.

Background and Summary of Ordinance Provisions

Currently, LAAC Sections 20.36 and 22.816 provide that the City Clerk shall conduct Neighborhood Council elections during the months of April, May and June of each even-numbered year. The draft ordinance allows the City Clerk to delegate its election responsibilities to the Department during the 2014 election cycle. The Department and the City Clerk each will adopt comprehensive regulations addressing the procedures that they will administer and oversee during the 2014 elections. LAAC Section 22.801.2 governed the Department's administration of elections in 2012 and is being deleted, as it is obsolete.

In addition, we recommend that the City Council approve the enclosed Resolution which will amend the Plan to reflect the changes made to the election system. The changes to the Plan reflect that the 2014 elections will be jointly administered by the City Clerk and the Department. Article V, Section 3 of the Plan regarding the resolution of election grievances has been deleted and is, instead, now located within the proposed ordinance, allowing either the City Clerk or the Department to create all rules necessary for the resolution of election challenges.

An ordinance amending Sections 20.36 and 22.816 and deleting Section 22.801.2 of the Los Angeles Administrative Code regarding Neighborhood Council elections.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Section 20.36 of Article 1 of Chapter 3 of the Los Angeles Administrative Code is amended in its entirety to read as follows:

Sec. 20.36. Neighborhood Council Elections.

- (a) The City Clerk is authorized to conduct Neighborhood Council board member elections during the months of March, April, May and June of each even-numbered year pursuant to a schedule to be developed by the City Clerk in consultation with the Neighborhood Councils and pursuant to this section, except that the elections conducted during the 2014 calendar year will be jointly administered by the City Clerk and the Department of Neighborhood Empowerment (Department). The City Clerk is authorized to delegate election responsibilities to the Department for the 2014 election cycle and is authorized to enter into a Memorandum of Understanding with the Department that specifies each party's role and responsibility for the 2014 election cycle.
- (b) The City Clerk shall be authorized to promulgate any election procedure, rule, regulation, or issue any directive or moratorium necessary for elections administered by the City Clerk and any portion of elections administered by the City Clerk during the 2014 election cycle, including the promulgation of any procedures, rules, regulations, directives, moratoria for the resolution of any election challenge. During the 2014 jointly administered election, the Department shall be authorized to promulgate any election procedure, rule, regulation, or issue any directive, moratorium or rule necessary for that portion of the election administered by the Department, including the promulgation of any procedures, rules, regulations, directives, moratoria for the resolution of any election challenge.
- (c) A Neighborhood Council's bylaws may be amended by the City Clerk or Department to ensure that the bylaws comply with this section, the Los Angeles Administrative Code, or the Plan for a Citywide System of Neighborhood Councils. Any election procedures, rules or regulations promulgated by the City Clerk or Department are hereby incorporated into all Neighborhood Council bylaws by reference and are to be affixed to the Neighborhood Council's bylaws. The election rules and regulations shall take precedence over any inconsistent language in the Neighborhood Council's bylaws.

- (d) The City Clerk and Department are authorized to charge a manual recount fee in the amount of \$798.80 per Neighborhood Council, and \$2.28 for each additional ballot required to be recounted beyond the estimated average number of ballots cast in a Neighborhood Council election, to any stakeholder, as defined in Los Angeles Administrative Code section 22.811(a)(2), who voted in a Neighborhood Council election and who has requested a recount.
- Sec. 2. Section 22.801.2 of Article 1 of Chapter 28 of the Los Angeles Administrative Code is deleted in its entirety.
- Sec. 3. Section 22.816 of Article 3 of Chapter 28 is amended in its entirety to read as follows:

Sec. 22.816. Neighborhood Council Elections.

Neighborhood Council board member elections shall be administered pursuant to Section 20.36 of this Code.

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records. RESOLUTION

WHEREAS, on March 19, 2013, City Council requested that the Office of the City Attorney prepare and present a draft ordinance granting authority to the City Clerk and the Department of Neighborhood Empowerment to jointly administer Neighborhood Council board members elections in 2014; and

WHEREAS, Article V in the Plan for a Citywide System of Neighborhood Councils regarding Neighborhood Council elections should also be amended to reflect these changes.

NOW, THEREFORE, BE IT RESOLVED that the Plan for a Citywide System of Neighborhood Councils is hereby amended as follows:

1. Article V of the Plan is amended in its entirety to read:

Neighborhood Council Elections

1. Compliance

Neighborhood Councils that choose to elect their Governing Body will have their elections administered pursuant to Los Angeles Administrative Code Section 20.36.

2. Governing Body Operations

Neighborhood Councils shall be empowered to allocate the Governing Body seats, determine voting rights, including the allocation of different voting roles to different categories of Community Stakeholders and establish other voting procedures, consistent with the Charter, this Plan and the Regulations that implement this Plan, and any procedures issued by the City Clerk or DONE. Any Governing Body structures and voting systems adopted should not limit broad participation by Community Stakeholders of a Neighborhood Council.

3. Violations

A violation of the election procedures shall constitute a violation of this Plan and may subject a Neighborhood Council to the decertification procedures set forth in Article VI of this Plan, either upon submission of a complaint as outlined in Article VI, Section 4 of this Plan, or by DONE filing a report with the Commission asking it to consider decertification, after having first taken steps in an effort to achieve compliance with the election procedures.
