Hello Mr. Villanueva,

This is the second time I am requesting this e-mail be added to City Council File/Motion 11-2057 as evidence that my rights under California's Public Records Act are being violated.

I requested access and or copies of specific documents outlined below, documents that Legislative Deputy Erick Martell has gone on record stating that exist and he has. Yet, despite several PRA requests, I have not been given access to these documents.

I want this FAILURE TO COMPLY with a request under California's Public Records Act to be entered to the official record of Motion 11-2057.

—ORIGINAL REQUEST BELOW—

Please add this e-mail to City Council File/Motion 11-2057, in regards to my PRA request. I would like for this to be part of the official record, as my rights continue to be violated. The documents requested under the Public Records Act has not been fulfilled.

Specifically the records having to do with:

1. Exactly when the community of Rose Hills existed: the City of Los Angeles records that verify when Rose Hills became an official community as well as the official boundaries of this said community,

and

3. Any evidence that the Neighborhood Council for El Sereno (LA32) supports the placement of community identification signs in the Rose Hills area: the agendas and official minutes of when the LA-32 NC General Board reviewed, discussed and voted on this item.

In regards to #1, nothing that has been presented by either Anthony Manzano or Legislative Deputy Erick Martell verifies when exactly was Rose Hills created as a community nor the boundaries of this said Rose Hills community. It has been over 2 months since this request was made and I have yet to receive these documents.

Legislative Deputy Erick Martell stated that he would be providing us and submitting the requested documents to City Council File/Motion 11-2057 on June 18, 2013, during the first Education and Neighborhoods Committee meeting; this is documented on the Committee's audio recording. Mr. Martell has not turned over the requested documents and he has been in violation, as it is within my rights to have a copy or be able to review these requested documents. Unless these are presented to me, Motion 11-2057 cannot be sent to added to City Council's agenda, as my PRA request are incomplete and the law is being broken.

In regards to Item #3, I know there is a letter within Mr. Manzano's said Archives of Rose Hills that states the local LA-32 NC supports this motion, but the letter is written and signed by Mr. Manzano himself, who was President of the NC at the time the letter was written. The agendas and official minutes need to be included in order for this letter of support from LA-32 NC to be valid;DONE has already stated this in prior NC meetings. Otherwise it's simply a letter Mr. Manzano wrote that cannot be verified as true.

Again, please add this e-mail to the City Council File for Motion 11-2057. Also, please clarify if it is against the law for this Motion 11-2057 to be added to the City Council's agenda when my rights are being violated in regards to the requested Public Records Act documents that have yet to be fulfilled. Legislative Deputy Erick Martell has not provided any of the requested documents as he stated he would during the past Education and Neighborhoods Committee meetings. Thank you.
