REQUEST TO AMEND CONTRACTS WITH SERVICE PROVIDERS UNDER THE 2012-13 HOUSING OPPORTUNITIES FOR PERSONS WITH HIV/AIDS (HOPWA) PROGRAM, APPROVAL OF REVISIONS TO THE 2013-14 HOPWA PROGRAM BUDGET AND AUTHORIZATION TO EXECUTE CORRESPONDING HOPWA CONTRACT AUTHORITIES FOR THE 39TH PROGRAM YEAR CONSOLIDATED

PLAN - LOS ANGELES HOUSING DEPARTMENT (LAHD)

SUMMARY

The Los Angeles Housing Department (LAHD) requests approval to amend contracts with nine current service providers under the 2012-13 Housing Opportunities for Persons with HIV/AIDS (HOPWA) Program along with the corresponding authority to execute the amended contracts. A total of \$1,178,366 of unallocated HOPWA funds will be utilized as follows: 1) increase the number of emergency beds for persons with HIV/AIDS in downtown Los Angeles from 13 to 33: 2) increase the amount of monthly rental assistance provided through the Project-Based Rental Assistance (PBRA) program by 25 percent; 3) increase the number of Housing Specialist and Residential Services Coordinator staff to ease the workload impacts on service provision. compliance and reporting requirements; and 4) develop permanent supportive housing projects. Additionally, LAHD requests the transfer of \$118,514 to cover contractual services expenditures. Lastly, LAHD seeks approval on revisions to the allocation amounts and contract authorities for the HOPWA Program under the 39th Program Year (PY) Housing and Community Development Consolidated Plan (Consolidated Plan). This Office recommends approval of the actions proposed in this Report.

The purpose of the HOPWA Program is to provide housing and supportive services to low-income persons living with HIV/AIDS and their families. Under the Consolidated Plan, LAHD has administered the HOPWA Program since the 1990s. As the sole recipient of HOPWA funds in Los Angeles County, LAHD is required to provide services countywide. LAHD currently contracts with 26 agencies, 24 non-profit organizations (NPOs) and four Public Housing Authorities (PHAs).

to provide these core services throughout Los Angeles County. Two additional contractors provide administrative support to the HOPWA Program, one for technical assistance and resource identification and the other for monitoring and fiscal risk assessments of all HOPWA-funded agencies. The PHAs were contracted on a sole-source basis, while the selection of all other agencies is the resultant outcome of the 2011 HOPWA Request for Proposals (RFP). Initial contracts for the 26 NPOs, two technical assistance contractors and one PHA were executed for a six-month term effective October 1, 2011 through March 31, 2012, with the option to renew for two one-year terms and one six-month term, not to exceed a total of 36 months, and subject to the availability of funds, on-going needs and satisfactory performance evaluations by LAHD (Council File 11-2120). First amendments were executed through the Consolidation Plan budget process for a one-year term effective April 1, 2012 through March 31, 2013 (Council File 11-1593). The City approved funding allocations and executed contracts with the three remaining PHAs for initial 18-month terms effective October 1, 2011 through March 31, 2013 (Council Files 11-2120 and 11-1593).

Proposed Contract Amendments

The City received \$15,305,260 in HOPWA funds through the 38th PY Consolidated Plan (April 1, 2012 through March 31, 2013). Of this amount, \$14,126,894 was allocated for HOPWA contractors, program administration and the Affordable Housing Trust Fund (AHTF) for permanent supportive housing development. The balance of \$1,178,366 was held in reserve pending input from the advisory committee process. LAHD is requesting authority to allocate a portion of the reserve funds (\$212,900) to execute amendments with nine contractors under the Supportive Services and Housing Subsidies categories of the HOPWA Program. The additional funds will allow enhanced services as follows: six agencies to add Housing Specialist or Residential Services Coordinator staff to facilitate supportive services to clients; two agencies to increase emergency shelter bed capacity by 20 beds; and one agency to increase rental assistance subsidies by 25 percent at 35 HOPWA units. See Attachment 1 of the LAHD Transmittal for a detailed breakdown of the allocation of these funds.

The remaining balance of \$965,466 would be allocated to the AHTF to support the development of permanent supportive housing projects. Current plans include the issuance of a Notice of Funding Availability for permanent supportive housing sometime in 2013. Additionally, LAHD is requesting \$118,514 that was over appropriated in the Housing Subsidy Assistance category be reallocated to the Supportive Services (\$103,611) and Service Provider & General (\$14,903) categories in order to adequately support contractual expenditures.

Revisions to the 39th PY Consolidated Plan - HOPWA Program

The 39th PY Consolidated Plan was approved on February 27, 2013 (Council File 12-1607). Subsequent to this action, LAHD conducted a further review of all HOPWA accounts and identified an additional \$1.5 million in program savings. This amount, when added to the \$1.2 million previously identified results in a revised total of \$2.7 million to be disbursed among the various HOPWA Program categories. This program savings amount is slightly higher than usual due to a couple of factors: 1) stricter eligibility requirements reduced the number of participants

for the Housing Subsidy Assistance Program – Short Term Rent, Mortgage, Utility, and 2) the declining income of HOPWA clients reduced the number of participants in the Permanent Housing Placement Grant Program. The use of program savings to finance the front end of HOPWA contracts will serve to alleviate cash flow issues for many of the service providers. The estimated HOPWA Entitlement of \$15.3 million plus \$2.7 million in program savings increases the budget total to \$18 million. The following chart shows a summary comparison of the original and revised HOPWA Program budget funding allocations.

Additionally, LAHD reported the successful retention of the non-profit organization Behavioral Health Services, a contractor under the HOPWA Emergency Shelter and Transitional Housing as well as the Supportive Services in Permanent Housing categories. LAHD requests the rescission of the old Attachments D and M approved on February 27, 2013 and the replacement and approval of the revised allocations listed in Attachment D dated March 18, 2013 and authority to negotiate and execute contracts in accordance with the revised list of proposed contractors and amounts in Attachment M dated March 18, 2013 and attached to this Report.

RECOMMENDATIONS

That the Council, subject to the concurrence of the Mayor:

1. Authorize the General Manager, LAHD, or designee, to negotiate and execute contract amendments substantially similar to Attachment 2 of the LAHD transmittal dated February 7, 2013, between the City and the nine proposed HOPWA service providers as identified in Attachment 1 of the LAHD transmittal dated February 7, 2013, subject to the review of the City Attorney as to form and compliance with City contracting requirements, for the three-month period effective January 1, 2013 through March 31, 2013 and for the funding amounts included in Attachment 1, subject to satisfactory contractor performance as determined by LAHD, available funding and ongoing need;

2. Authorize the Controller to:

- a) Expend funds for the contracts between the City of Los Angeles and the agencies listed in Attachment 1 of LAHD's February 7, 2013 transmittal from Fund 569 not to exceed the amounts listed in Attachment 1 of LAHD's February 7, 2013 transmittal upon proper demand of the General Manager, LAHD, or designee;
- b) Transfer appropriations within HOPWA Fund No. 569, Department 43, in the amount of \$1,296,880 as follows:

FISCAL IMPACT STATEMENT

There is no impact on the General Fund. Approval of these recommendations will authorize the Los Angeles Housing Department (LAHD) to execute contract amendments with nine service providers for enhanced services, transfer appropriations within HOPWA consistent with these actions, and approve revised HOPWA funding recommendations and contracting authorities to the 39th Program Year (PY) Consolidated Plan. The funding source is previously approved federal HOPWA monies. These recommendations comply with the City's Financial Policies in that the full cost of these services will be paid through special funds sources.

REVENUE

The 39th Program Year (PY) Housing Opportunities for Persons with AIDS (HOPWA) budget proposes a total amount of \$18,005,266, which is the estimated HOPWA Entitlement, plus \$2,700,006 in program savings from prior years, an increase of 18%. This program serves the entire County of Los Angeles.

Housing Subsidy Assistance - \$7,941,570

HOPWA Subsidy Assistance programs give low-income persons living with HIV/AIDS, and their families, short and long-term financial assistance to help them access and retain affordable housing throughout Los Angeles County. This budget category includes Tenant-based Rental Assistance (TBRA), Project-based Rental Assistance (PBRA), Short-Term Rent, Mortgage and Utility Assistance Program (STRMU),

Scattered Site Rental Assistance, Permanent Housing Placement, Emergency Motel Vouchers and Transitional/Short Term Housing. The total amount for this budget category increased in the 38th PY due to guidance from HUD requiring the Permanent Housing Placement program funds (i.e. \$916,050) to be included in this line item; it was previously in the Housing Placement Assistance Activities category, which has been reduced accordingly and renamed Information Services. The Permanent Housing Placement Grant provides financial assistance for a security deposit and first month's rent, not to exceed twice the rent amount. It may be used in conjunction with subsidized or market rate housing. Four (4) local housing authorities implement the TBRA Program: the Housing Authority of the City of Los Angeles (HACLA), the Housing Authority of the County of Los Angeles (HACoLA), the Housing Authority of the City of Long Beach and the Pasadena Community Development Commission. The other program services are provided by community-based organizations selected through a competitive Request for Proposal (RFP) process.

Supportive Services-\$5,175,010

HOPWA Supportive Services programs assist low-income persons living with HIV/AIDS and their families to improve their access to housing, financial resources, employment, health care, and enhances their quality of life. The program includes supportive services for clients in permanent housing and housing locator services. Other services include meal preparation/delivery, food banks, meal vouchers, mental health counseling, benefits counseling, and legal assistance. Services are provided by project sponsors selected through a competitive Request for Proposal (RFP) process.

Technical Assistance/ Resource Identification-\$525,000

Contractors will be used to provide technical services and resource identification services related to the HOPWA program, including training for service providers and implementation of an HMIS-type database to track HOPWA clients and outcomes. Shelter Partnership will provide various services including strategic planning, proposal development, survey and program design, report writing, facilitating housing case management contractor trainings, advising LAHD on newly enacted federal regulations and provisions related to the HOPWA program, and other tasks as needed. This budget category has been increased significantly to provide sufficient funds for both RFP development, contractor training, and best practices research, and for the HMIS development, information, and grantee and contractor HIMS set-up and initial training.

Adsystech will create a Homeless Management Information System (HMIS) module for the HOPWA program; it currently provides similar services for the Los Angeles Homeless Services Authority (LAHSA), which under contract to LAHD, administers the City's homeless services programs. HMIS is the federally-mandated information system that is strongly recommended by HUD for use in HOPWA programs; the LAHSA version needs to be modified to incorporate health privacy concerns for HOPWA clients to comply with the federal Health Insurance Portability and Accountability Act of 1996 (HIPAA). In addition to economic efficiencies in using Adsystech, we will be able to coordinate LAHSA's and HOPWA's HMIS which will enable better tracking of clients who are served by both LAHSA and HOPWA programs.

Permanent Supportive Housing Development- \$2,523,437

In years when the budget permits, HOPWA funds have been combined with other resources in the Affordable Housing Trust Fund NOFA, for Permanent Supportive Housing Program development, to be leveraged with CDBG and HOME funds, the State Multifamily Housing Program (MHP), HUD's 811 Program, Low Income Housing Tax Credits and other housing resources to develop affordable housing for persons living with HIV/AIDS and their families.

Housing Information Services - \$250,000

HOPWA Information Services provides funding for a website and hotline for clients seeking housing. The total amount for this budget category decreased in the 38th PY due to guidance from HUD requiring the Permanent Housing Placement program funds (i.e. \$916,050) to be included in the Housing Subsidy Assistance budget category instead of this line item.

Housing Management Information Systems (HMIS) - \$125,000

For the first time, in the 39th Program Year, HUD is allowing jurisdictions to set aside HOPWA program funds for grantee staff to develop and operate the HMIS system for HOPWA service contractors. This category will pay for LAHD systems staff to work in conjunction with Adsystech (mentioned above under Technical Services/Resource Identification category, to develop and implement the HOPWA HMIS module, including training for all contractors, tracking, contractor assistance, and so forth.

Administrative Costs - \$1,465,249

Oversight, management, monitoring, and coordination of the HOPWA grant-funded programs and activities. The HOPWA Program allows 10% of the grant to be used for administration: 7% must go to the project sponsors and 3% can be used by the grantee, the Los Angeles Housing Department. However, since three of the HOPWA line items are not given project sponsor administrative funds (i.e. *Technical Assistance, Housing Development, and HMIS*) the seven percent of administrative resources that would have applied to those funds is instead allocated to program costs. Therefore, the total amount of administrative funds for the HOPWA grant this year is less than the maximum 10%. Unfortunately, the LAHD cannot simply use the extra funds for its administrative costs since the percentages are set by statute.

The HOPWA funds are insufficient to pay for the full staffing and other costs needed to implement this countywide program, so CDBG funds must be used to supplement them. The HOPWA-funded auditing services provided to the non-profit project sponsors, which was previously included in the *Technical Assistance* line item, must now be paid from the Grantee (LAHD) HOPWA administrative funds, which further reduces the resources available to adequately operate this countywide program.

REVISED 3.18.13. LAHD is requesting authority to amend the Housing Opportunities for Persons with AIDS (HOPWA) contracts for an additional 12 months. All services are provided to low-income persons living with HIV/AIDS, many of whom are homeless. LAHD administers the HOPWA grant on behalf of the entire County of Los Angeles, as directed by Federal statute, which also requires that each HOPWA service provider be allocated administrative funds in addition to program dollars, which is shown in the charts below.

Note 4: Shelter Partnership's (SP) contract, which received contract authority and was executed pursuant to LAHD's Housing Studies RFQ rather than the HOPWA RFP, expires as of 3/31/13. An entire new contract must be executed for PY 13-14, not an amendment. LAHD received approval through CF 12-1470 to execute an initial contract with SP for PY 13-14 for \$28,000 using HOPWA funds. However, this amount will be insufficient for all the work SP will be required to undertake related to developing and releasing a new HOPWA RFP. Therefore, LAHD has allocated additional funds to add to the contract after the initial contract is executed.

Note 5: In the 38th year Con Plan budget, LAHD allocated Technical Assistance/Resource Development funds to Adsystech to develop and implement the federal Homeless Management Information System (HMIS) customized to HOPWA requirements (e.g. HIPAA). However, a contract was not executed due to staff shortages and other HOPWA issues that took precedence. This year LAHD plans to execute the contract and has allocated funds for systems development, implementation, and training for a minimum of 24 HOPWA contractors.
