Dear Members of the Transportation Committee,

I am writing to you as a co-founder of Keep Rowena Safe, a community organization which was formed to protect the safety improvements on Rowena Ave including the current lane configuration (the "road diet") and to advocate for further safety improvements around Silver Lake. I strongly support the further safety measures for Rowena Ave and the surrounding streets as detailed in LADOT's analysis of the Kimley-Horn report commissioned by CD4. In particular, the community needs a new signalized crosswalk at either Herkimer St. or Avenal Terrace as well as a lead pedestrian interval for the signal at W. Silver Lake Blvd. Rowena also currently suffers from inadequate lighting at night (particular east of W. Silver Lake where there are several restaurants).

The LADOT analysis also proposed either buffered or parking protected bike lanes. Since the bike lanes were added to Rowena, there has been a 500% increase in the number of people on bikes using Rowena. Further enhancing the safety of people on bikes would most likely lead to even more people using the bike lanes with the added benefit of fewer people using automobiles for short trips and the corresponding reduction in greenhouse gases. Fixing the gap in the bike lanes at the intersection of Rowena and Hyperion would also increase safety for people on bikes. I would also like to see CD4 and LADOT look at ways to connect the bike lanes on Rowena to the well used bike lanes on Griffith Park Blvd (which also desperately needs to be repaved) and to the LA River Bike Path and Atwater Village.

Finally, Kimley Horn and LADOT also proposed mitigations for "cut-through" traffic on both Angus St. and Waverly Ave. and I would like to see action taken and mitigations funded for both these neighborhood streets.

I hope that the members of this committee will see the benefits of increased safety on our streets and find appropriate funding sources for these needed safety and infrastructure improvements.
