Dear Mayor and City Council Members:

The City of La Cañada Flintridge supports your amended Resolution 12-0002-S82 opposing the F-7 Alternative. We have long opposed any highway alternative (below or above the ground) as a solution to the problem of congestion in the 710 extension north area. We believe that such a solution is a 20<sup>th</sup> century solution to a 21<sup>st</sup> century problem.

As you are aware, Metro staff is recommending only five alternatives for consideration within the EIR/EIS: No Build; TSM/TDM; BRT 6 with further refinements; LRT 4 with further refinements; and/or F-7 (freeway tunnel).

Therefore, the only highway alternative remaining is the tunnel. For residents of your City and for residents of ours, we believe the F-7 Alternative poses very serious environmental risks. Additionally, the tunnel is estimated to cost billions, and yet no cost/benefit analysis has been conducted. Metro's own study showed that the tunnel would operate at a Level of Service F (at peak times) in the very near future. Therefore, billions of dollars would potentially be spent for a project that would likely not show a positive impact, and would possibly show a worsened impact, with respect to resolving the congestion issue.

Additionally, Metro, thus far, has made no attempt in the environmental process to study freight-to-rail to reduce goods movement through the area, stating that they believe that only a small number (3%) of trucks will reach the project area (despite the fact that the planned 710 corridor south would have 12 lanes with dedicated truck lanes). Metro has not yet shown what assumptions have been made to substantiate the small number of trucks they claim will reach the project area nor have they demonstrated how past studies are flawed.

If the F-7 tunnel was built, we believe it would mean that some of your neighborhoods would be disturbed in the building of the tunnel portal, and once constructed, traffic would be idling there (based on Metro's own conclusion that gridlock would occur). Residents supposedly relieved of congestion would likely suffer the same or even increased congestion and air pollution.


