WHEREAS, Monica Palacios is currently a distinguished lecturer at UC Santa Barbara and UCLA, and has also taught at Loyola Marymount University, The Claremont Colleges, the American Academy of Dramatic Arts, and UC Riverside; and

# **CHRIS PAUL** "CP3"

Whereas, Chris Paul was born in Lewisville, North Carolina in 1985 as the son of Charles and Robin Paul where he played basketball at South Carolina-Spartanburg; and

Whereas, Chris Paul was taught the importance of hard work as a youth where spent his summers working at Jones Chevron, a local service station owned by his grandfather; and

Whereas, Chris Paul attended Wake Forest University and played for the Demon Deacons for two seasons, leading them to the NCAA tournament. As a freshman, he was named the ACC Rookie of the Year, Third Team All ACC, an All-American Honorable mention and broke five Wake Forest freshman records; and

Whereas, Chris Paul was drafted by the New Orleans Hornets in the first round of the 2005 NBA draft. In his rookie season, he led all rookies in points, assists, steals and minutes, earning him the 2006 NBA Rookie of the Year Award; and

Whereas, Chris Paul had successful seasons in New Orleans from 2005 to 2011; and

Whereas, Chris Paul was traded to the Los Angeles Clippers in December of 2011 where he was selected as a starter for the 2012 NBA All-Star Game. In addition, he also became the first Clipper to be named to the All-NBA First Team since the Clippers moved to Los Angeles; and

Whereas, Chris Paul initiated a philanthropic campaign designed to highlight his dedication to the community of Winston-Salem where he was born and raised. These efforts have led to the refurbishment of basketball courts at the Rupert Bell Recreation Center, the establishment of an AAU program in Winston-Salem called "CP3 All-Stars" and his annual "Chris Paul's Winston-Salem Weekend" which has raised over \$300,000 for local charities, the Nathaniel Jones Scholarship Fund at Wake Forest University and West Forsyth in memory of his late grandfather; and

Whereas, Chris Paul has also put together a Day of Service, Youth Basketball Clinic, Celebrity Bowling Event and Community Church Service for communities closest to him. In addition, he and his brother C.J. teamed up with Rouses Supermarkets and donated \$50 dollar gift cards to 100 families to purchase Thanksgiving meals in 2009, donated 100 \$100 shopping sprees at Toys 'R' Us to New Orleans children; and

Whereas, Chris Paul is an avid bowler who owns his own ball and shoes and serves as a national spokesperson for the United States Bowling Congress; and

Whereas, Chris Paul provided 3,000 hurricane preparedness kits to residents of the New Orleans community and also provides tickets to underprivileged youth with his player ticket group; and

Whereas, On October 21, 2012, Chris Paul will be releasing his Jordan Brand CP3 VI in the City of Los Angeles. In addition, he will be hosting 2,000 youth from different neighborhoods in Los Angeles where they will be participating in a variety of activities along with the Los Angeles Fire Department:
