Metropolitan Division Training Unit

Whereas, Following the 1992 Civil Unrest, the Los Angeles Police Department recognized the need to be able to rapidly assemble and deploy officers in a platoon size formation for unusual occurrences; and

Whereas, During the examination of the crowd control tactics of other agencies and adapting those tactics to the needs of the LAPD, Metropolitan Division developed the Mobile Field Force concept; and

Whereas, Metropolitan Division, first trained the LAPD on a Department-wide basis in 1992-1993. That first iteration of Mobile Field Force training was termed "Camp Snoopy," and was conducted at Dodger Stadium. During that time, Metro also developed and delivered a training program for recruit officers; and

Whereas, In 2000, the nation experienced several violent and destructive protests surrounding issues facing the World Trade Organization; and

Whereas, In anticipation for the 2000 Democratic National Convention, the LAPD asked Metropolitan Division to provide the Department with an updated Mobile Field Force training. The second iteration of training became known as "Mobile Field Force 2000," and it was conducted at the Elysian Park Academy and Dodger Stadium; and

Whereas, The events surrounding the 2000 DNC and the 2007 May Day protests caused the Department to review its policies and procedures related to crowd control; and

Whereas, In 2007-2008, Metropolitan Division was once again asked to develop a lesson plan and tactics that incorporated recommendations made by the courts following the above events. Metropolitan Division's third iteration of training became known as "21st Century Crowd Management and Control Training." In an effort to facilitate the training quickly, the Department moved the training to the Los Alamitos Joint Operations Base; and

Whereas, Recognizing that Mobile Field Force Tactics are perishable skills and in an effort to comply with the May Day Structural Relief Order, the Department established guidelines to continue in-service training for all officers; and

Whereas, In 2011, the LAPD established a 2-year training cycle requiring all members of the Department to be trained in Mobile Field Force tactics. Metro was once again asked to develop and implement the training. The forth iteration, which is the current training cycle, is simply referred to as Crowd Management and Control Training and is being conducted at the Ahmanson Recruit Training Center and at an off-site location at 98th Street and Aviation Boulevard. The primary responsibility for Mobile Field Force training falls upon Metro's B-Platoon, C-Platoon, E-Platoon, and Training Coordination Unit (Metro TCU); and

Whereas, The 2011-2012 Crowd Management and Control Training is a 10-hour POST certified course that covers the following topics:
Review of past Tactical Incidents, Crowd Management vs. Crowd Control, Types of Crowds, Unlawful Assembly Penal Code sections, Use of Force
Policy Review, Baton Techniques, Mobile Field Force and Squad Tactics, and Arrest Team Procedures:

NOW, THEREFORE, BE IT RESOLVED, that by the adoption of this resolution the Los Angeles City Council does hereby commend and congratulate Metropolitan Division B-Platoon, C-Platoon, E-Platoon, and Training Coordination Unit (Metro TCU) for all of their hard work and dedication to develop and implement the Crowd Management and Control Training.

Whereas, Dr. Mahfouz Michael is engaged to Bibiana Alchultz, a Colombian-American, who is committed to the work of the chain of clinics known as Clinica Medica San Miguel; and

Whereas, the success of Clinica Medica San Miguel is due in part to the staff of Medical Doctors, Nurses and Administrative Assistants;

Whereas, in 2012, Dr, Mahfouz Michael, will celebrate the 30th anniversary of providing services to the City and County of Los Angeles; and

Whereas, Dr. Mahfouz Michael has supported low income immigrant families and the work of the Latin American International Coalition; and

FALL OF BATAAN 70TH Anniversary

WHEREAS, April 9, 1942 is remembered in world history as the fall of Bataan in the Philippines, where 90,000 troops of the United Sates Armed Forces in the Far East consisting of Filipino and American soldiers surrendered after five months of fighting Japanese forces valiantly and succeeding in delaying the Japanese forces ability to conquer the Pacific; and

WHEREAS, after the fall of Bataan, Japanese soldiers forced these Filipino and American soldiers whose heroic efforts were integral to the United States' ultimate victory in World War II, through the infamous Bataan Death March of 55 miles in 14 days, which killed 30,000 soldiers and forced the survivors into concentration camps; and

WHEREAS, General Douglas MacArthur stated that the participation of Filipinos in World War II was shortened by 55 days, saving the United States \$ 15,000,000,000 and thousands of American lives; and

WHEREAS, still there are many Filipino American World War II veterans and their widows living within the United States, including the Temple-Beverly/Echo Park area or the Historic Filipinotown of Los Angeles whose service is to be recognized:

NOW, THEREFORE BE IT RESOLVED that by the adoption of this resolution the City Council of the City of Los Angeles honors the heroic efforts of Filipino veterans who fought at the fall of Bataan and on to the liberation of the Philippines in 1945, 70 years ago.

JOHN CUSACK

WHEREAS, John Cusack has received a star on the World Famous Hollywood Walk of Fame on Tuesday, April 24, 2012; and

WHEREAS, John Cusack has evolved into one of the most accomplished and respected actors of his generation, garnering prestigious accolades for his dramatic and comedic roles. Cusack will next be seen in Mikael Håfström's Shanghai, a period piece in which he stars opposite Gong Li and Chow Yun-Fat. In this remake of the 1935 thriller of the same name, Cusack plays an American man who explores a corrupt, Japanese-occupied Shanghai four months before Pearl Harbor in order to solve the murder of his friend; and

WHEREAS, Cusack recently starred in *Hot Tub Time Machine*, a comedy co-starring Rob Corddry, Craig Robinson and Clark Duke about friends who return to the ski lodge where they partied as youths and are transported back in time to 1987. Cusack produced the film through his New Crime Productions banner, which has produced several of his recent cinematic outings; and

WHEREAS, Cusack also starred in Roland Emmerich's apocalyptic epic **2012**. This international blockbuster, which grossed more than \$766 million worldwide, co-starred Chiwetel Ejiofor, Thandie Newton, Woody Harrelson, Danny Glover, Amanda Peet and Oliver Platt; and

WHEREAS, in 2008, Cusack voiced the title character in the animated family film *Igor*. He also starred in, wrote and produced the political satire *War, Inc*. with co-stars Marissa Tomei, Hilary Duff and Joan Cusack. The previous year, he starred in James C. Strouse's *Grace is Gone*, which premiered at the 2007 Sundance Film Festival and was recognized with the Audience Award. Cusack also starred in Menno Meyjes' romantic comedy *Martian Child*, opposite Amanda Peet, Oliver Platt and Joan Cusack; and

WHEREAS, Previously, Cusack was seen in Mikael Håfström's horror hit **1408**, with Samuel L. Jackson; Harold Ramis' dark comedy **The Ice Harvest**, alongside Billy Bob Thornton; Gary Fleder's **Runaway Jury**, opposite Hollywood legends Gene Hackman and Dustin Hoffman; James Mangold's **Identity**, with Amanda Peet, Alfred Molina and Ray Liotta; Menno Meyjes' controversial drama **Max**, opposite Noah Taylor; Tim Robbins' **Cradle Will Rock**, an ensemble drama featuring Emily Watson, Susan Sarandon and John Turturro; and Mike Newell's comedy **Pushing Tin**, with Billy Bob Thornton, Angelina Jolie and Cate Blanchett; and

WHEREAS, Cusack first gained the attention of audiences by starring in a number of 1980s film classics such as *The Sure Thing*, *Say Anything*, *Sixteen Candles* and *Better Off Dead*. The actor would shed his teen-heartthrob image by starring in a wide range of dramas, thrillers and comedies including *The Grifters*, *Eight Men Out*, *Adaptation*, *Being John Malkovich*, *High Fidelity* and *Grosse Pointe Blank*; and

WHEREAS, in 2001, Cusack was nominated for a Golden Globe Award® for Best Performance by an Actor in a Comedy or Musical for his role in *High Fidelity*, the feature-film adaptation of Nick Hornby's novel. In 1999, Cusack starred in the dark comedy *Being John Malkovich*, receiving an Independent Spirit Award nomination for Best Actor; and

WHEREAS, Other film credits include Peter Chelsom's **Serendipity**, Terrence Malick's **The Thin Red Line**, Simon West's **Con Air**, Clint Eastwood's **Midnight in the Garden of Good and Evil**, Harold Becker's **City Hall**, Woody Allen's **Bullets Over Broadway** and **Shadows and Fog**, Joe Roth's **America's Sweethearts**, Alan Parker's **The Road to Wellville**, Herbert Ross' **True Colors**, James L. Brooks' **Broadcast News** and Rob Reiner's **Stand By Me**; and

WHEREAS, on the small screen, Cusack starred in HBO's telefilm "*The Jack Bull*," a traditional Western written by his father Dick Cusack. He also served as executive producer on the film; and

WHEREAS, Cusack currently divides his time between Los Angeles and Chicago:

WHEREAS, Over the span of a 50 year career, from BATMAN to the voice of Quahog's mayor on FAMILY GUY, Adam West has become a television icon; and

WHEREAS, Born in Walla Walla, Washington as William West Anderson, Adam began his career as a radio DJ and TV show host. WHEREAS, It's been said the biggest pop-culture phenomena of the 1960's can be boiled down to the "Three B's": Beatles, Bond, and BATMAN; and

WHEREAS, In the early 1960's *Batman* was simply a cartoon character in a comic book that was close to cancellation, but Adam West's performance in the ground-breaking TV adaptation propelled *Batman* into becoming one of the most famous characters in modern fiction. West's turn as the "classic" Batman has laid the foundation for the success of all the incarnations of the "Caped Crusader" that have followed after him. The smash success of the TV series, and the feature film that followed shortly thereafter, launched Adam West into international superstardom in 1966; and

WHEREAS, after its original run, **BATMAN** entered into non-stop syndication and Adam West has continued to garner new generations of fans all over the world for the past 40 years. All the while, he's continued to work on stage, in movies and TV, and as a much sought-after voice actor; and

WHEREAS, It's his wildly successful career as a voice actor that has brought him his most recent triumph as "Mayor Adam West" on the hugely popular, and critically acclaimed, TV series FAMILY GUY on the Fox network; and
