# M O T I O N

The Street Furniture Revenue Fund provides funds for transit related projects, sidewalk projects, curb / sidewalk improvements, beautification projects needed to improve conditions for public transit patrons, and all expenses relating or incidental thereto, as well as on general services to the community in each Council District.

The Hollywood Beautification Team will be conducting maintenance activities at the Sunset Triangle Plaza. This effort is of special benefit for the residents of the City and for CD-13 and deserves financial assistance from the City.

Sufficient funds are available in the Council District 13 portion of the Street Furniture Revenue Fund which could allocated for this purpose.

I THEREFORE MOVE that \$10,000 in the Council District 13 portion of the Street Furniture Revenue Fund No. 43D Dept. 50 be utilized / allocated / appropriated for the Hollywood Beautification Team maintenance activities at the Sunset Triangle Plaza, and that the Bureau of Street Services be directed to prepare and execute the necessary document(s), and/or payment(s) to Hollywood Beautification Team, or any other agency or organization, as appropriate, in this amount and for this purpose.

I FURTHER MOVE that Bureau of Street Services be authorized to make any technical corrections or clarification as necessary to the above instructions in order to effectuate the intent of this Motion.
