# COUNCIL TRANSMITTAL: REQUEST FOR AUTHORITY TO EXECUTE THREE-MONTH AMENDMENTS WITH CURRENT TECHNICAL SERVICES CONTRACTS

### **SUMMARY**

The Los Angeles Housing Department (LAHD) requests authority to execute three-month amendments with current technical service contractors to extend the term of the contracts through March 31, 2013.

On April 24<sup>th</sup>, 2012 the Mayor concurred with the City Council action (CF12-0194) authorizing LAHD to release a Request for Proposals (RFP) for technical services. LAHD released the 2012 Construction and Technical Service Request for Proposals on October 30, 2012 to select new technical services contractors. LAHD received 23 proposals on December 11, 2012 and is currently reviewing and scoring these proposals. These contract amendments to extend the current service term will ensure continuity of the services necessary to support LAHD programs, such as Homeownership, Rehabilitation, Affordable Housing Development and the Neighborhood Stabilization Program (NSP). For successful implementation of the various housing programs, LAHD relies on contractors with specialized expertise to perform the required technical services. To effectively achieve these goals, LAHD has determined that it is necessary to amend these contracts by increasing the time of performance.

#### RECOMMENDATIONS

The General Manager, of the LAHD, respectfully recommends:

- 1. That your office schedule this transmittal at the next available meeting(s) of the appropriate City Council committee(s) and forward it to the City Council for consideration and approval immediately thereafter;
- 2. That the City Council, subject to the approval of the Mayor, authorize the LAHD General Manager or designee to execute contract amendments with the technical service contractors, (shown in table 1 below) and add three months to the existing contract term beginning January 1, 2013 through March 31, 2013 and to allow these contractors to utilize the funding that was identified in previous contracts and amendments. The authority for the previous amendments is contained in City Council files 12-0194, 10-2441, and 09-0374, and the funds previously authorized are HOME, CDBG, NSP, and Lead grant.

3. Authorize the LAHD General Manager or designee to prepare Controller instructions and any necessary technical adjustment(s), consistent with Mayor and City Council actions, subject to the approval of the City Administrative Officer, and authorize the Controller to implement the instructions.

## **BACKGROUND**

The LAHD Major Projects division administers a wide variety of programs and services. These programs and services range from loans for rental housing production, first-time homebuyer loan programs, Neighborhood Stabilization Program (NSP), rehabilitation programs, to lead abatement. To implement a myriad of programs that require a wide range of technical services, the LAHD has identified contractor resources where in-house skills and expertise do not exist or would otherwise be financially infeasible to maintain.

#### FISCAL IMPACT

There is no fiscal impact on the General Fund. The contracts are paid through federal grants and special funds such as HOME Investment Partnerships Program (HOME), Lead Grant Funds (LEAD), and Neighborhood Stabilization Program (NSP).
