TRANSPORTATION COMMITTEE REPORT relative to the administrative procedures for processing requests from the Council and Mayor to not enforce certain parking restrictions.

Recommendation for Council action:

RECEIVE and FILE Department of Transportation (DOT) report to Council dated June 19, 2012 (attached to the Council file), relative to the administrative procedures for processing requests from the Council and Mayor to not enforce certain parking restrictions in the Los Angeles Municipal Code.

Fiscal Impact Statement: Not applicable.

Community Impact Statement: None submitted.

SUMMARY

In a report to Council dated June 19, 2012, DOT presents the administrative procedures for processing requests from the Council and Mayor to not enforce certain parking restrictions. DOT states that only parking laws established by the Council and Mayor are eligible under this program. The City of Los Angeles has no authority to waive state parking laws codified in the California Vehicle Code. Requests to not enforce parking restrictions can be made for expired meters; time limit and time of day restrictions; preferential, overnight, and oversize parking districts; passenger or school bus loading zones; and, street cleaning. Parking enforcement for red zones, including bus zones, alleys, sidewalks, handicapped zones, "No Parking Anytime" (including "Tow Away") and "No Stopping Anytime" zones, and all temporary "No Stopping" or "No Parking" zones must be enforced and cannot be waived.

At its meeting held June 27, 2012, the Transportation Committee recommended that Council receive and file DOT's report.
