I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the cases entitled Fix The City, Inc. v. City of Los Angeles, Los Angeles Superior Court (LASC) Case No. BS138580; La Mirada Avenue Neighborhood Association of Hollywood v. City of Los Angeles, LASC Case No. BS138369; Save Hollywood.Org, et al. v. City of Los Angeles, LASC Case No. BS138370. (This matter involves challenges to the City Council's June 19, 2012 adoption of the Hollywood Community Plan Update and its environmental impact report), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of \$1,750,779.88 in settlement of the above-entitled matters from the City Attorney Fund No. 100, Department 59, Account 009770.
2. AUTHORIZE the City Attorney, or designee, to draw demands from Fund No. 100, Department 59, Account 009770 as follows:
  - a. \$600,000 payable to Strumwasser & Woocher, LLP Client Trust Account
  - b. \$780,000 payable to Silverstein Law Firm, APC
  - c. \$120,779.88 payable to Richard Scott MacNaughton
  - d. \$250,000 payable to Angel Law
3. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.

This matter was recommended for approval by the Budget and Finance Committee (Krekorian – Koretz - Blumenfield - Bonin "yes") at its meeting on June 2, 2014, in Closed Session as permitted by Government Code Section 54956.9(d)(1).
