At the regularly scheduled publicly noticed meeting of the Greater Griffith Park Neighborhood Council (GGPNC) on March 20, 2012, the board agreed by consensus to send you the following:

On December 8, 2011, the City Planning Commission (CPC) approved the Draft Hollywood Community Plan (DHCP) and FEIR corrections.

After 8 years working on this plan, the GGPNC commends the CPC for the creation of the DHCP, but we have our concerns due to the population decrease from 1990 to 2010 that has occurred. The DHCP is based on data that is no longer correct due to the 2010 Census. Therefore, we request that:
