For today City Council meeting, Agenda Item 4, HCP/FEIR/Proposed Zoning Changes see below and the attachment.

The attachment is the compilation of GGPNC Board's comments and recommendations on the Draft HCP, Draft EIR, starting in 2005 and continuing through into 2011. GGPNC representatives spoke and provided comments staff and elected official public hearings, including the City Planning Commission, which approved the proposed plan unanimously, Plan Dept. workshops and public hearings, and PLUM in 2011 and 2012. Councilmen LaBonge and Garcetti received most of the comments and recommendations in the original mails.

***The Department of City :Planning staff, Mary Ricardson and Kevin Keller (and other staff) over the entire preparation

period responded to all emails from the GGPNC within 24 hours, appeared in person to make presentations and

respond to questions at GGPNC planning committee and Board meetings, including a Board meeting in 2012 to respond to questions on a variety of issues.***

On balance, the HCP and FEIR, with mitigation measures, and zoning proposals and procedures provides goals, policies,

programs for various interests--residential neighborhoods, parks and open space, historic and distinctive architectural

buildings, low and moderation income housing, business, and others. Also included is a chapter on design guideline and a Nexus

study to examine the use of development fees to address growth impacts on infrastructure.

The current Hollywood Community Plan from 1988 does not have the above features.

The plan and department staff respond positively to stakeholder recommendations for the GGPNC area.

Issues to be addressed include a few areas with no restriction on height; current and forecasted population, employment,

and housing; ways to include the more detailed design standards proposed by the staff of the Los Angles CRA, recently

eliminated.

Best for discussion and action today and/or this month on the HCP, FEIR, and related zoning proposals.

There are two sets of enclosures. One set includes general comments made by some of the nearly 50 stakeholders on the evening of March 30, 2011, Wednesday at the GGPNC and its Planning, Zoning, and Historic Preservation Committee forum on the DHCP and DEIR. The forum consisted of a power point presentation by the Planning Department staff, questions and answers, and public comments. All the audio portions were recorded.

The second set of enclosures are the official questions, comments, and recommendations approved by the GGPNC Board, based on proposals from its committees. These six documents were submitted to the planning department, as well as elected and appointed city officials. They are dated as follows: May 5, 2005, July 18, 2006, April 15, 2008, May 25, 2010, August 24, 2010, and December 31, 2010.

This submittal from the workshop and the re-submittal of past comments is based on an email and telephone conversation with Kevin Keller, Mary Richardson, and Richard Spicer after the March 30, 2011 workshop as the the way to ensure that past and current comments from the GGPNC will be responded to in writing. The Department estimates that these responses will be in August or September 2011, as part of a workshop and public hearing for stakeholders in the Hollywood Community Plan area.
