The ECIS was constructed and completed in 2004 to relieve the east-west segment of the North Outfall Sewer from its outlet connection to the North Central Outfall Sewer, which conveys flows from the Baldwin Hills area, to the vicinity of Mission Road and Jesse Street.

What testing, analysis and monitoring will be conducted for any harmful effects of odors, sediment or other material from the oil and gas fracking fluids from Baldwin Hills? Fracking liquid content is proprietary.

Will there be any Prop 65 Hazardous Material?

Will there be possible groundwater contamination?

Will this project contribute to any Total Daily Maximum Loads TMDLs in the LA River Watershed Management Area? What mitigation is planned?

The proposed project is in a Methane Zone. Your data is from 2005 and old.

On the Methane (and other Gases) Mitigation, what is your Plan for reporting, timeframe for inspections and continued compliance? Will you be using an Active or Passive System and at what level?

What standards will be used (National Fire Academy)?

At what levels will fire, police and emergency services be staffed and what is the anticipated response time under an emergency situation? Will those positions be funded and filled?

How are evacuations handled?

Is the Emergency Dispatch System working properly?

South Coast Air Quality Management District has not obtained 1-hour ozone attainment with EPA in the California State Implementation Plan. What monitoring stations will you employ?

Without monitoring, testing and compliance, the risk to Public Health and Safety is an issue that involves Air Quality, Hazards and Hazardous Material, Water Quality and Nuisances.
