Dear LA City Council Members; Vincent Bertoni, and DCP Re:CODE LA and Palms-MV-DR Community Planners:

At its regular board meeting on Dec. 11, 2018, the Mar Vista Community Council (MVCC) unanimously passed (vote: 10/0/1) the following motion regarding the Re:CODE LA initiative:

*CF 12-0460-S4 is a "proposed ordinance amending the Los Angeles Municipal Code to comprehensively reorganize the administrative provisions of the Zoning Code and establish a new Article and Chapter to the Los Angeles Municipal Code". These "Policies and Procedures" extend more than 940 pages. We are unable to properly comprehend this legislation without more time to analyze it.*

*The Mar Vista Community Council (MVCC) requests that City Council consideration of CF 12-0460-S4 be delayed for at least 90 days from January 1, 2019 to allow stakeholders and the MVCC adequate time to analyze the ordinance.*

MVCC appreciates the advocacy of the City Council, particularly that of Council Members Bonin and Koretz, on behalf of stakeholders requesting more time to review this important legislation.
