ECONOMIC DEVELOPMENT REPORT and ORDINANCE FIRST CONSIDERATION relative to amending the Los Angeles Municipal Code (LAMC) to include a definition of television pilots and to exempt the filming of television pilots from certain fees.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT the accompanying ORDINANCE amending Subsections (b) and (d) of Section 41.20 and adding Subsection (a)(11) to Section 41.20.1 of the LAMC to include a definition of television pilots and exempt the filming of television pilots from certain fees.
2. NOT PRESENT and ORDER FILED the Ordinance dated July 26, 2013.

Fiscal Impact Statement: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At a regular meeting held on August 27, 2013, the Economic Development Committee considered a report and Ordinance from the City Attorney dated July 26, 2013 relative to amending the Los Angeles Municipal Code to include a definition of television pilots and to exempt the filming of television pilots from certain fees.

A representative of the City Attorney appeared before the Committee to provide a brief overview of the proposed Ordinance and responded to related questions. During discussion of this matter, the Vice Chair of the Committee questioned the language in the Ordinance defining television pilots and referring to "Television Networks." The Vice Chair noted that the meaning of this phrase has changed in terms of the avenues in which television pilots can now be developed and distributed and moved that the Ordinance be amended with broader language relative to the definition of a television pilot.

After consideration, and after having provided an opportunity for public comment, the Committee Chair and members concurred with the recommendation of the Vice Chair and requested that the City Attorney amend the Ordinance to include a broader definition of television pilots and provide the amended Ordinance prior to this matter being scheduled for Council. The City Attorney presented an amended report and Ordinance dated September 9, 2013 which is now forwarded to the Council for its consideration.
